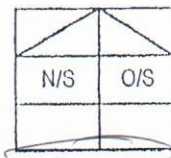

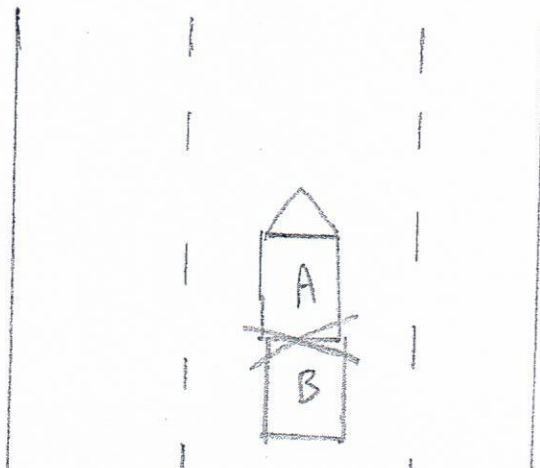

Brief Details.

On 11/10/2021 at about 1742hrs, I was driving my vehicle (SMY6969E) with a passenger inside along Tampines Road towards Defu. The traffic was heavy at the point of time and I managed to stop my vehicle after crossing the cross junction of Tampines Road and Hougang Avenue 3 due to the heavy traffic. Out of a sudden, I heard a loud bang and felt an impact from the rear of my vehicle. I check with my passenger if he is feeling ok and he said that he is not injured. I alighted from my vehicle immediately and discovered that the rear of my vehicle was hit by another vehicle (SGY5868R). The other driver and I move our vehicle to aside and we exchanged particulars before leaving the scene.

On the same day at about 1900hrs, I went to visit a GP at Care Medical Pte Ltd (Blk 683 Hougang Avenue 8 #01-931, Singapore 530683) as I felt some soreness on my neck and backbone. I was then given 5 days of MC from the doctor for Whiplash Injury.
