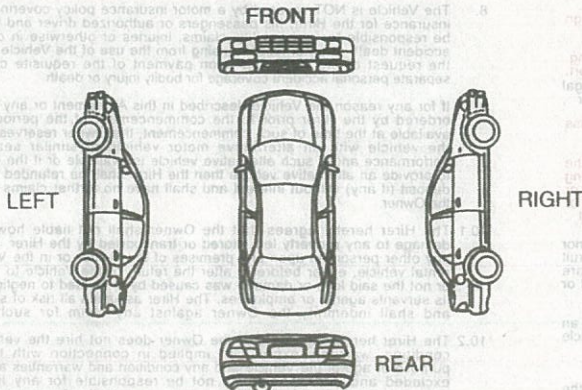

made with the opposite party's insurers, you will only commence repairs only upon receipt of
notification from my/our appointed solicitors that I/we have appointed to act for me/us in the claim
in respect of the above caption.
2. Pending notification by my/our solicitors to you, I/we authorise you to appoint a surveyor to survey
the damages to my vehicle and to do all necessary work ("the preliminaries") with a view to
expediting the repairs to my vehicle. In the event that I/we decide not to proceed with the repairs
to my vehicle after the preliminaries were done and/or arranged by you, I/we agree to pay for all
the expenses incurred for the preliminaries.
3. You shall not be liable for any delay in the repairs to my vehicle for delays occasioned by the delay
in notification by my/our appointed solicitors that I/we have appointed them to act for me/us in the
claim in respect of the above caption.
