Brief Details.

I managed to control the motorcycle but I felt great pain on my lower back because of the impact from my rear. I stopped my motorcycle and took photographs of the damages to the front part of the motortaxi and my rear plate number which was dented. I also exchanged particulars with the driver of the motortaxi. I went to see my doctor for injuries at Family Care Clinic and was given 3 days of MC. I wish to claim against the insurance company of the motortaxi company.
