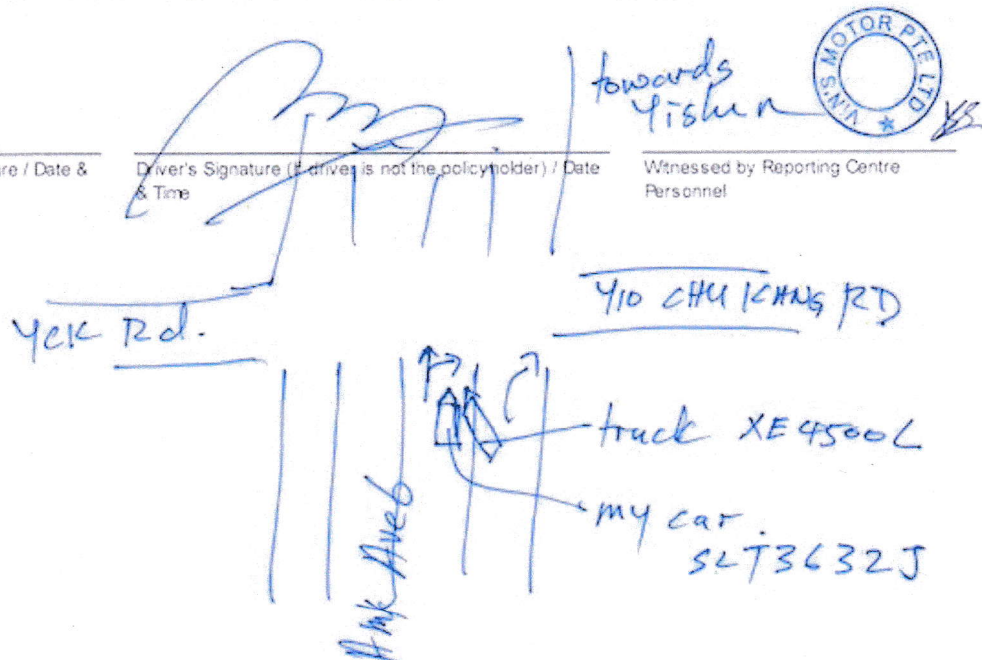

Describe Circumstances of the Accident

On 14th Oct 2021 9am, my car was stationary at the junction of AMPK Ave 6 & Yio Chu Kang Road.

I was waiting for the light to turn green for me to turn right into Yio Chu Kang Road.

When the light turned green, I discovered that my car did not move even when I step on accelerator. The next moment I felt the car being pushed to the left & when I turned to look I discovered the truck beside me (on my right) was has knocked onto the side of my car.

Abraid that the truck would continue pushing my car to the left, I turned the steering to my left to dislodge the car and move forward.
