Brief Details.

On 14/10/2021 at about 1600hrs, I was driving at the roundabout of Temasek Boulevard in my vehicle GBK6894R, as I wanted to go to Suntec Convention Hall. As I was driving on the third lane of the roundabout, I was going at a speed of about 20km/h. As I was passing Tower 3 and Tower 4, the exit to Temasek Avenue came up on my left.

Just as I was passing the exit, a red Toyota Harrier, SMC8694A, wanted to cut in to exit from the right into Temasek Avenue. I was focusing on an electric bicycle in front of me, and did not realize the vehicle turning towards me. By the time I realized, the vehicle's rear left passenger door had already collided with my front right bumper. Both of us alighted from the vehicle and he said I hit onto him. We did not talk much and we exchanged particulars and left quickly, as we were holding up traffic. In the time we were there, a few of his colleagues came down and rendered assistance to him.

I noticed that my van only sustained abrasion marks front right bumper, while his rear left passenger door was dented and scratches. I observe that he had no visible injuries, and could act normally. I did not sustain any injury as well. After driving away, I felt pain in my neck and upper back and my lower back. I went to KTPH to seek treatment and received 3 days medical leave.
