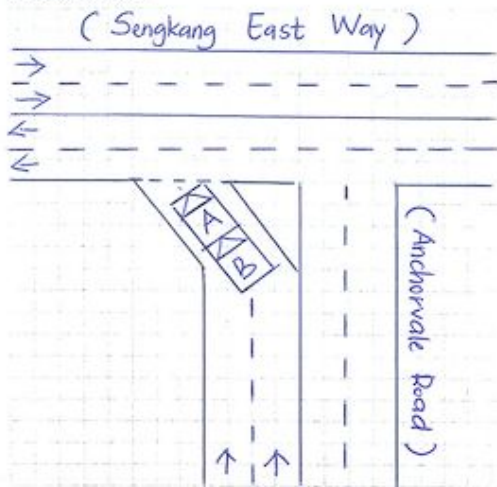

Location = Anchorvale Lane

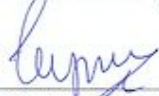
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Hence, I hereto lodge this report to claim against vehicle B (SKJ 8509 P)'s insurance for my vehicle accident damage.

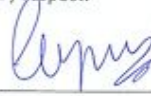
