- That I / We will personally attend to exchange cheque at your workshop within the stipulated time.

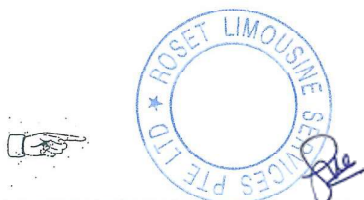
