S7124573Z, came to our assistance. After awhile, Traffic Police and Ambulance came. My wife was being conveyed to the NUH for further treatment. The right side of my motorcycle body sustained some damages and it grazed against the car and the ground during the collision. I am experiencing som pain on my right knee and I have some difficulty to walk. I also have some abrasion on my right elbow, the back of my right wrist and some pain on my right armstring, just below my right armpit. I will be visiting a clinic later today.

My wife is currently still in the NUH. James Tan was not injured and he was alone in his car. The front right side of his front bumper was damaged and the front carplate came out from the carplate bracket. I wish to state that James Tan had mentioned that he could not see my motorcycle until halfway of him turning right and that was why he stopped.

I was given a case card to lodge a Traffic Accident Report. Ref J/20211016/0142. My motorcycle is still able to be ridden.
