Sketch Plan

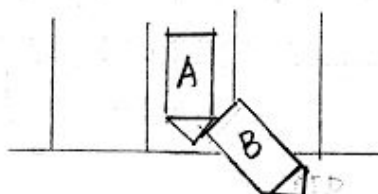
