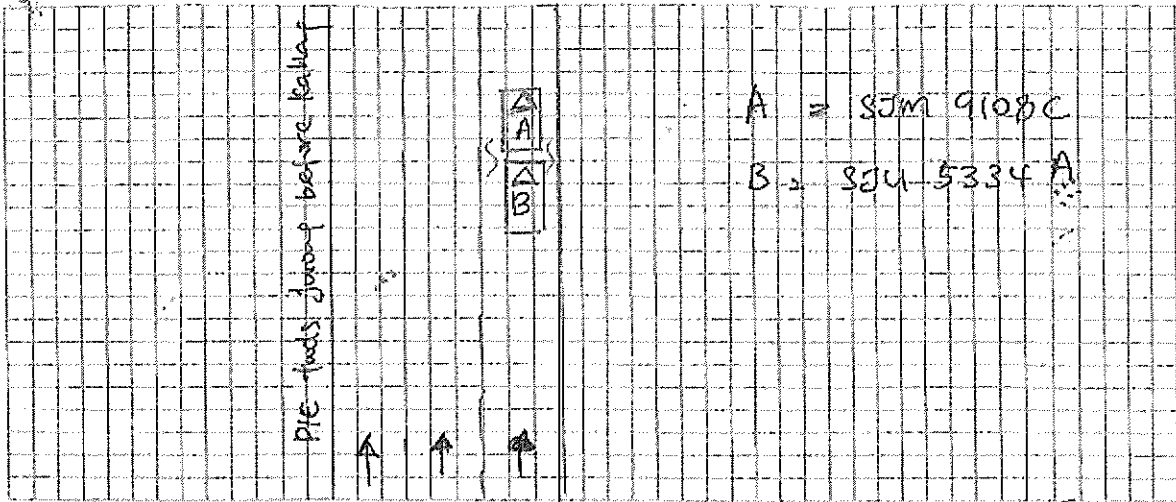

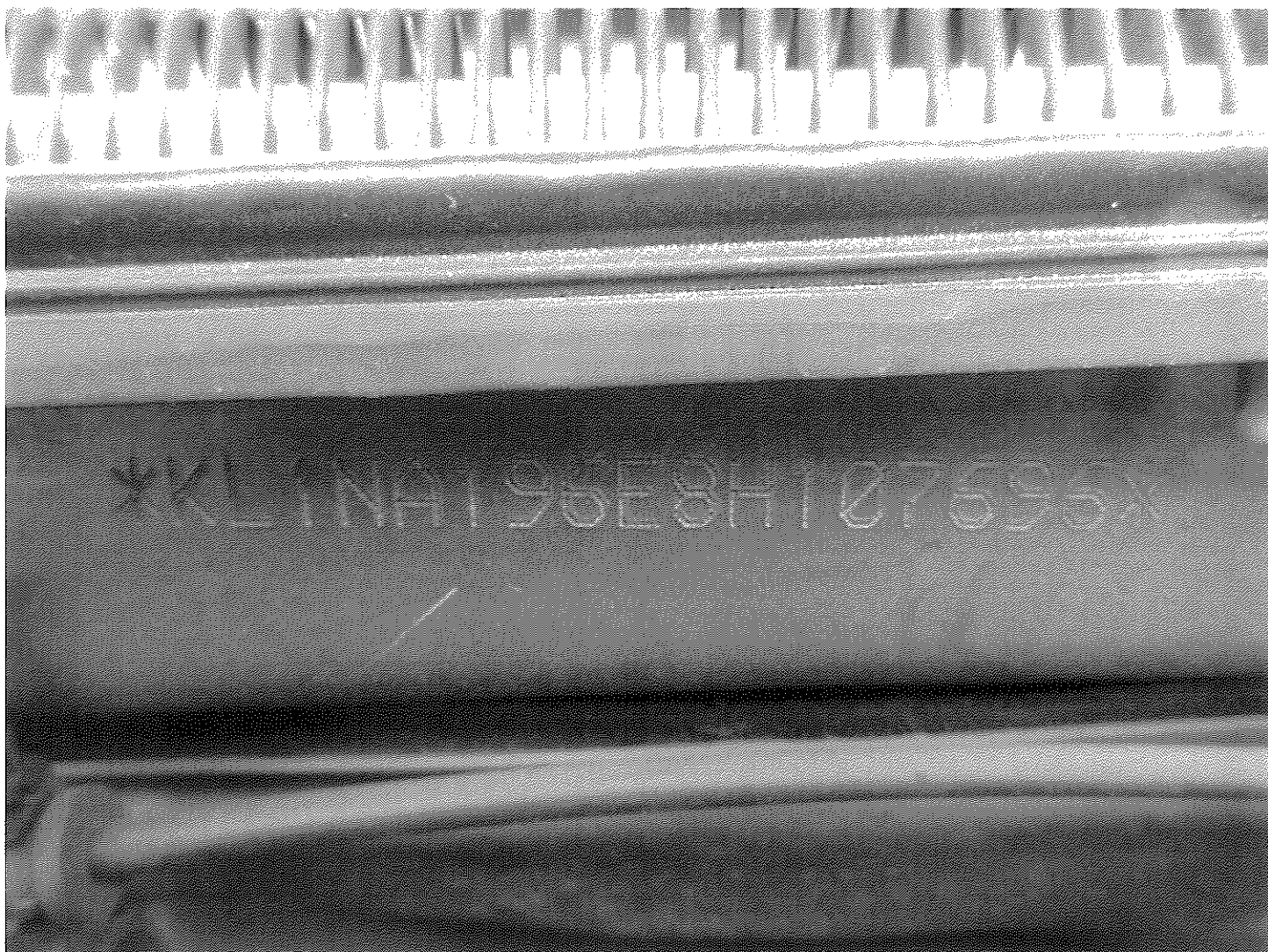

Brief Details.

On 27/10/2021 at about 2.50pm, I was driving my car SJM 9108C at along PIE Kallang towards Jurong.
