## Brief Details

On 24/10/2021 at about 0825hrs, I was riding my motorbike (JSK4363) along AYE, towards MCE direction, 12.5km near to Jurong Town Hall exit. I was in the third lane and suddenly, another taxl (\$H6959C) collided with my motorbike from my rear. The impact caused serious injuries to me as I was flung away from my motorbike. The Taxl stopped shortly after to attend to me. Police and paramedics attended to me and I was conveyed to NUH.

I suffered serious abrasions on my left arm, with stiches on my left elbow, and both of my ankles. I was given 27 days of MC and I was hospitalized for 2 days, from 24/10/2021 to 26/10/2021.
