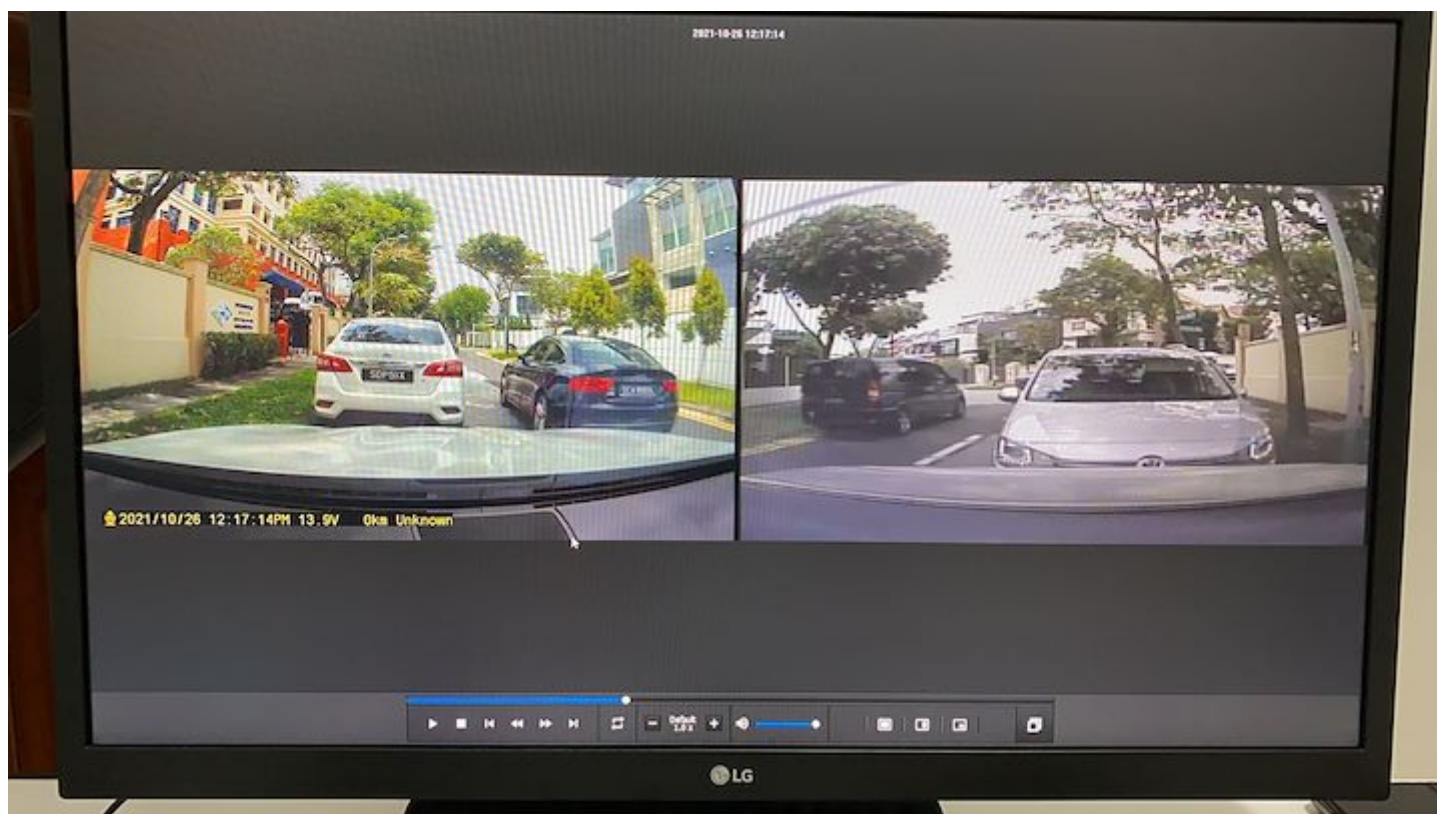

Brief Details.

On 26 October 2021 at around 1220hrs, I had parked my car bearing the registration number SGJ813K along Coronation Road near to Nanyang Primary School gate B. I was waiting for my son after his school. There were several other vehicles parked along the stretch of road. It was a two lane, one way road.

While I was waiting in the car stationary, all of a sudden, I heard a thud sound followed by an impact at the right side of my driver's door. I noticed a car had drove past on my right. I immediately pressed my honk to warn the driver to stop but the driver fail to stop and drove off. I later discovered that, there was some scratches at my right side mirror. I believed that the said vehicle might had grazed against my vehicle.

When I reached home, I decided to view my car camcorder recording pertaining to the earlier incident. The camera footage revealed that one dark colored car bearing SCA1993L had grazed against my vehicle. I am unsure how much the damages cost.
