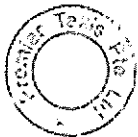

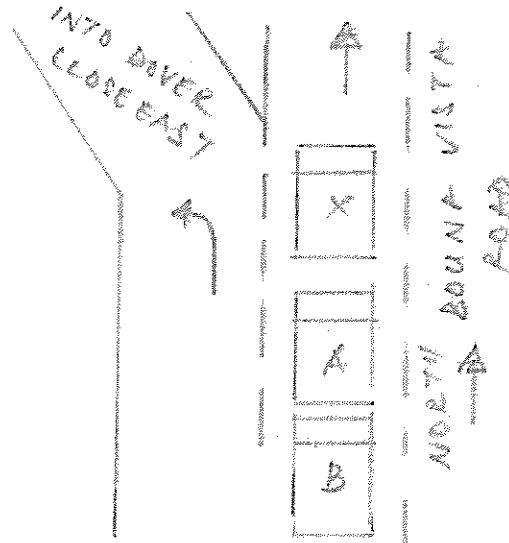

B: SDY1688E

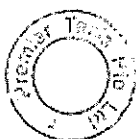

WHILE STATIONARY - SUDDENLY I FELT AN IMPACT FROM THE REAR.

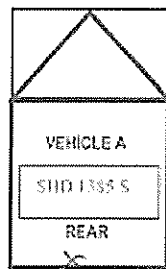
