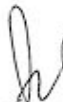
SKETCH PLAN

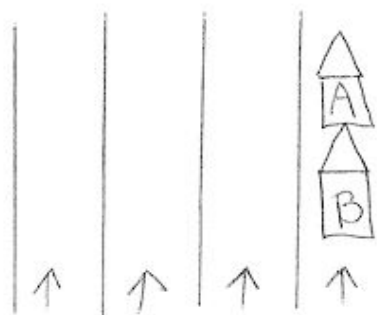
