

Upon instruction from LKK Auto Consultans Pte Ltd, I hereby make the following report.

25/10/21 @ 13.55 pm. I was driving my car SJS 474 along Toa Payoh Lg 1 heading for CHIJ. As I was overtaking a car (STU 2096U) from its right side, I heard a knocking sound from left side of my car as though it has contacted the other car.

Both the driver of STU 2096 U and I stopped by the roadside and examined both cars. But both of us couldn't find any damage, except a small dent of about the size of a 50¢ coin on the top of the right rear tyre mudguard. (Photograph was taken)
My car also has a 1 1/2 inches scratch at the side of my right rear mudguard.






