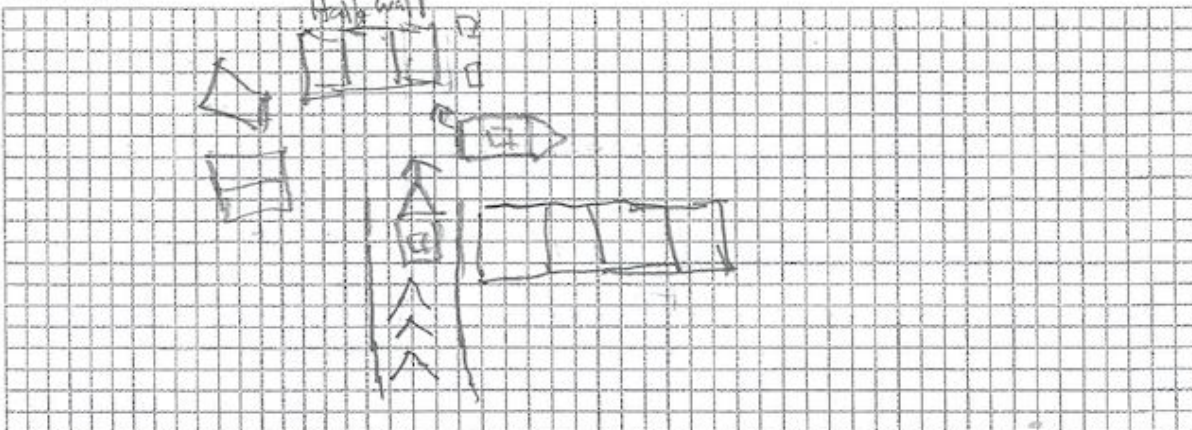

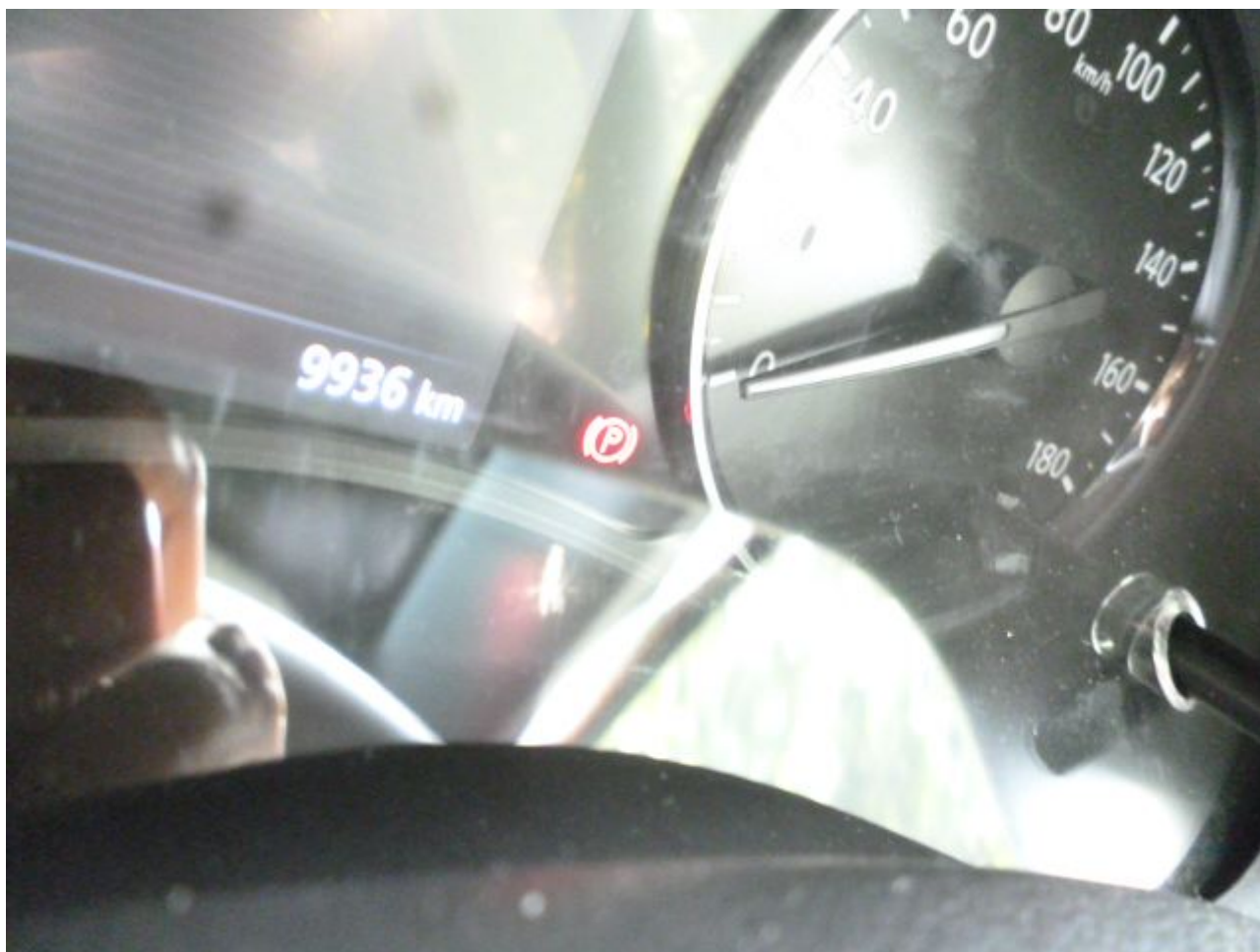

Brief Details.
