On 30 October 2021, our Insured was notified on a quotation raised by the authorized agent, Volkswagen Centre Singapore on the estimate for a private settlement, amounting to \$4,978.24 (before GST). There were only two primary items which were reportedly damaged in the minor accident, quoted by the said authorized agent.

Following, on or before 3 November 2021, we were notified on a Pre-Repair Survey (PRS) submitted by Rico 60 Auto Services acting on behalf of the third party owner for the same Volkswagen Golf.

An estimate of \$26,922.94 with a long list of items purportedly to be damaged, were also raised and submitted.

We then assigned the matter to Appraisals Associates Pte Ltd to investigate the matter.

It was later ascertained that fresh damages were noted on the Volkswagen Golf, as compared to those taken at the scene of the accident by the third party owner.

Hence, we strongly believed that those damages were intentionally inflicted to inflate the property damage claim.

We are lodging this report for CAD to investigate into this same syndicate
