Sketch Plan

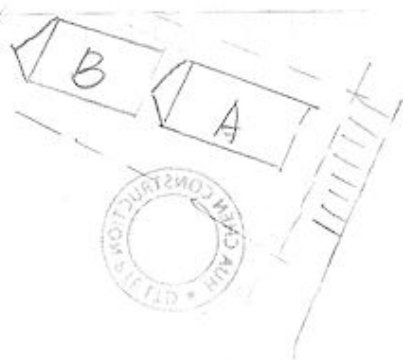


