



NOTICE OF REPORTING

This is to confirm that Yi Ming, FIN: G2528763R, has reported to the Police a non-injury traffic accident which occurred along Sengkang East Way towards Hougang Avenue 10 on 29/10/2021 at about 3.25pm involving the following 2 vehicles:

- 1) YP5565Z
- 2) SMY3833H

On 29/10/2021 at about 1525hrs, I was driving my vehicle YP5565Z along Sengkang East Way towards Hougang Avenue 10 and there was a vehicle SMY3833H (Female driver did not furnish her particulars) in front of mine. As we are approaching the traffic light, the light turns red and the vehicle brake while I was unable to brake in time and collided to the rear of the said vehicle. Both of us came out of our vehicles to take picture of the accident and no visible injuries on all parties. I provided my particulars to the other party, but she did not provide me with her particulars and mentioned that she will lodge an accident report with her car insurance company. There is in-car camera install in my vehicle, but it is spoilt so there is no recording. I informed my employer and will lodge accident report with insurance company tomorrow. My employer also advised me to lodge a police report to safeguard our company's interest.

2 If this accident was reported to the Police within 24 hours of its occurrence, then he/she has complied with Sec 84(2) of the Road Traffic Act, Cap 276.
