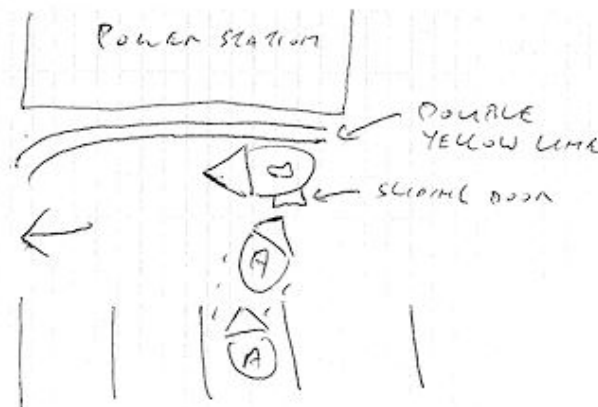

**Brief details.**

Traffic accident. Location: car-park at Blk 262, Serangoon Central.

At around 5.45 pm on Saturday, 23 October 2021, as I was getting ready to drive out of my parking lot, a MPV Toyota SMS 5845S drove in and parked in a carved-off area with double yellow lines running all around the power-station building (I believe that is a power station). As I was in a hurry, I decided to take a short-cut turning right when no vehicle was coming in. Unfortunately, my vehicle SBT 7003S grazed the left sliding door of the MPV.

I reversed and stopped to take a look at the extent of the damage to the MPV. The damage was quite

slight to the MPV but the driver (a woman) kept yelling and telling me to settle. We did not exchange our particulars which on hindsight, we should have done so. And I told her it would be better for us to make police reports as they (mother and daughter) have taken photos of my vehicle and the damage to their vehicle. But she kept yelling and telling me to settle. I should have calmed down and discussed with them a possible compensation for the damage.

Rather than prolong the arguments, I drove off but at the exit to the car-park, the woman stood in front of my car preventing me from exiting the car park. So I stopped there with the woman in front of my car. Again, I told the daughter as no physical injury was involved, making police reports is better. She told me instead that she was calling the police. (Isn't it an offence for someone to intentionally putting herself in harm's way?).

After several vehicles having to go round my vehicle to exit, I decided to reverse to the nearest parking lot. That was when a SCDF ambulance turned up which I thought was a mistake but the medic mentioned to me that they had reported that I had driven and injured the mother. I saw the medic spoke to the woman but did not see him medically examine her. I saw that she was moving around and squatting near the drainage.

Later a traffic policeman turned up and proceeded to ask both parties questions, took our NRICs, and later asked for my car SD card. He had to extract it as I did not how and he gave an acknowledgement slip to me. He asked me several times whether I hit the woman with my car.

It was more than an hour later that I left the car park for home.

I have received the SD card but the recorder in my car said it is damaged and I have put it aside. That's all.
