B - SBS 8789G



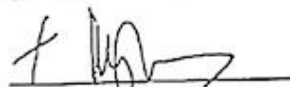

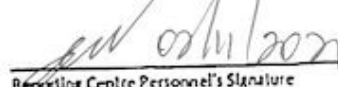
