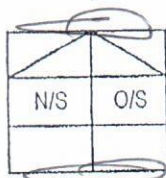


Rear portion pretty badly. Due to the impact, my vehicle bang onto the front vehicle.


