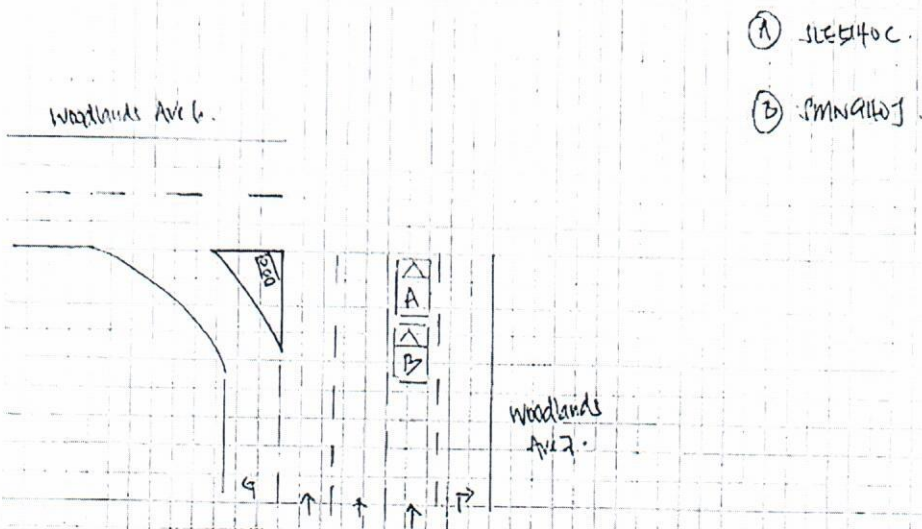

SKETCH PLAN




