

Describe Circumstances of the Accident

On 05/11/2021 @ 11:25hrs, I was driving SLH4279C in the carpark of block 219 Top Payoh Lorong B carpark. As I was exiting my parking lot, and while turning right, my steering was locked suddenly for a brief moment and I accidentally bumped into vehicle SLZ7658C in its parking lot. Vehicle SLZ7658C shifted in its lot and bumped into vehicle SMM3000H in its parking lot from the impact from my vehicle. Both parked vehicles (SLZ7658C and SMM3000H) had no passengers or drivers in the vehicle at the time of accident.

I took pictures of the accident and I left my particulars on the windshield of both vehicles, and have exchanged details with all relevant parties when they had contacted me. No one was injured in this accident.
