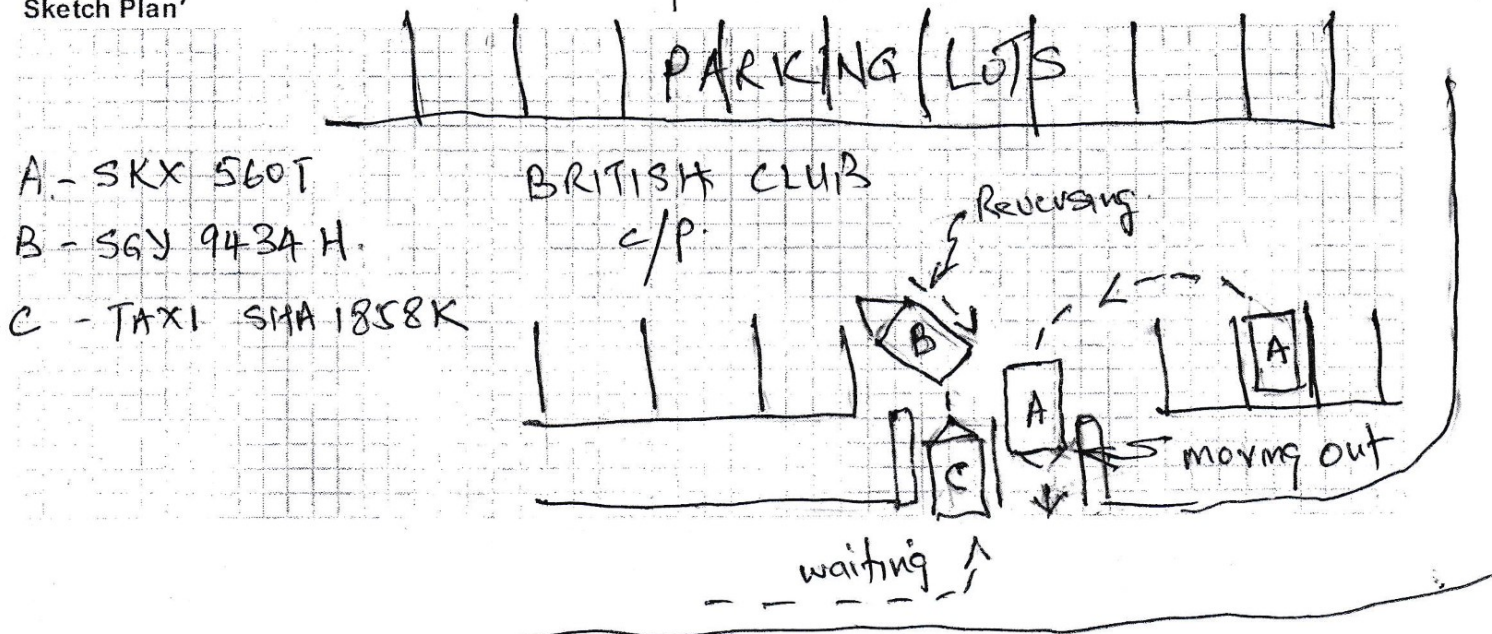

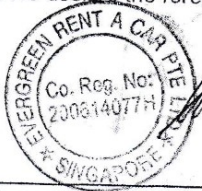
The Third Party car had entered the entrance into the club and for whatever reason had reverse suddenly and bump into my RH Rear car.


