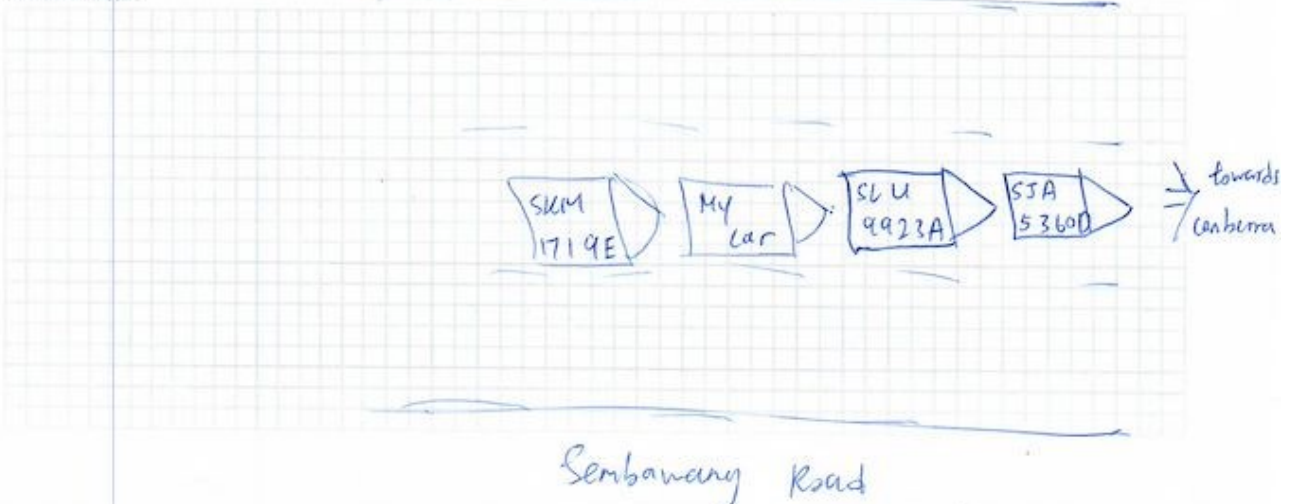
1. Please report correctly the details of the accident to speed up the claims process.

I stopped my Audi A4 (SLC6205D) behind Mr. Chan (Second car, SLV9923A) and Mr. MUHAMMAD (Last car, SKM1719E) came a high speed and crashed into the back of my car ~~surging forward~~ which ~~led~~ leads into my car surging forward and collided into the back of Mr. Chan (Second car, SLV9923A) and his car surging forward to colliding into Mr. ZULKIFLI, (SJA5360D, First car).


