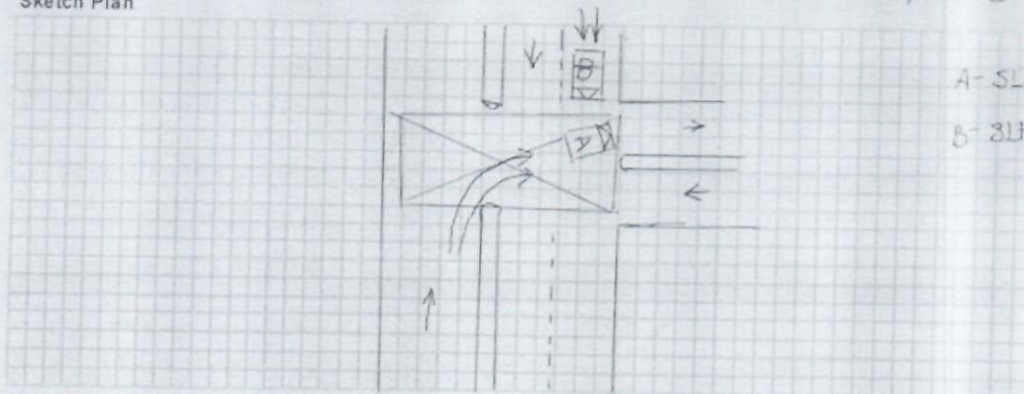

Sketch Plan


