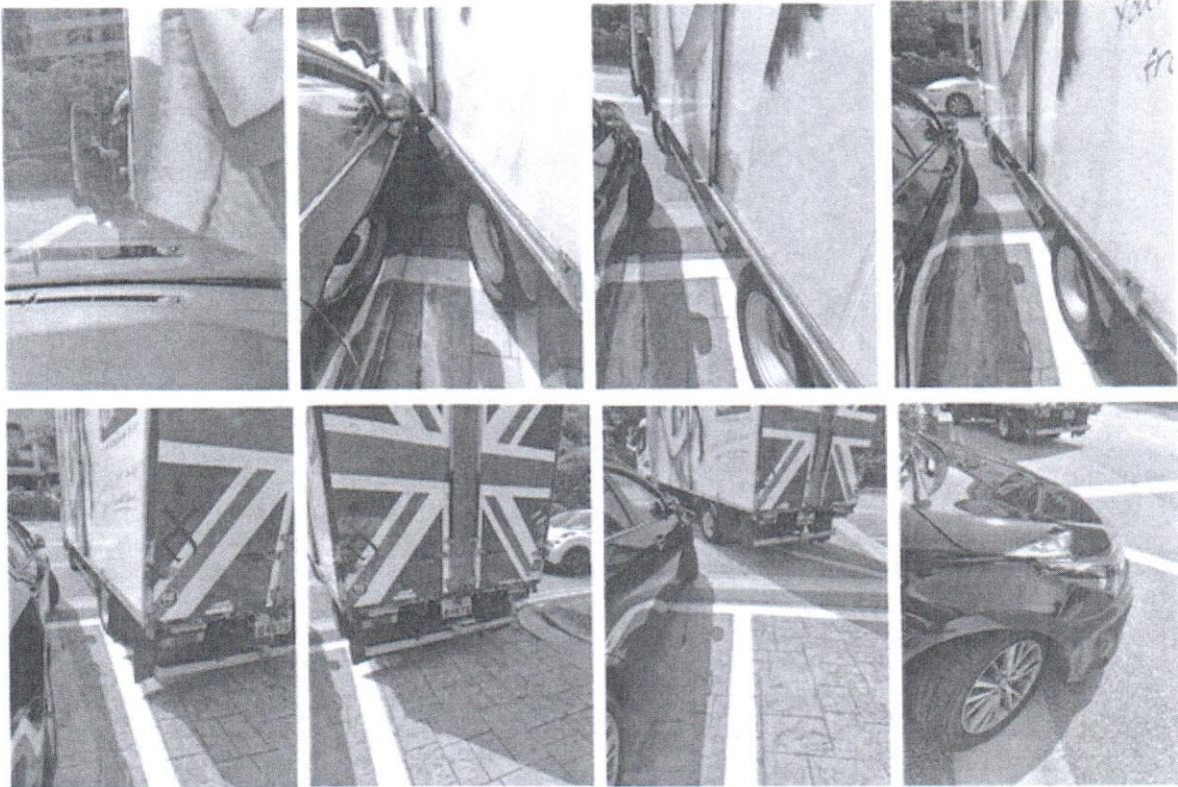

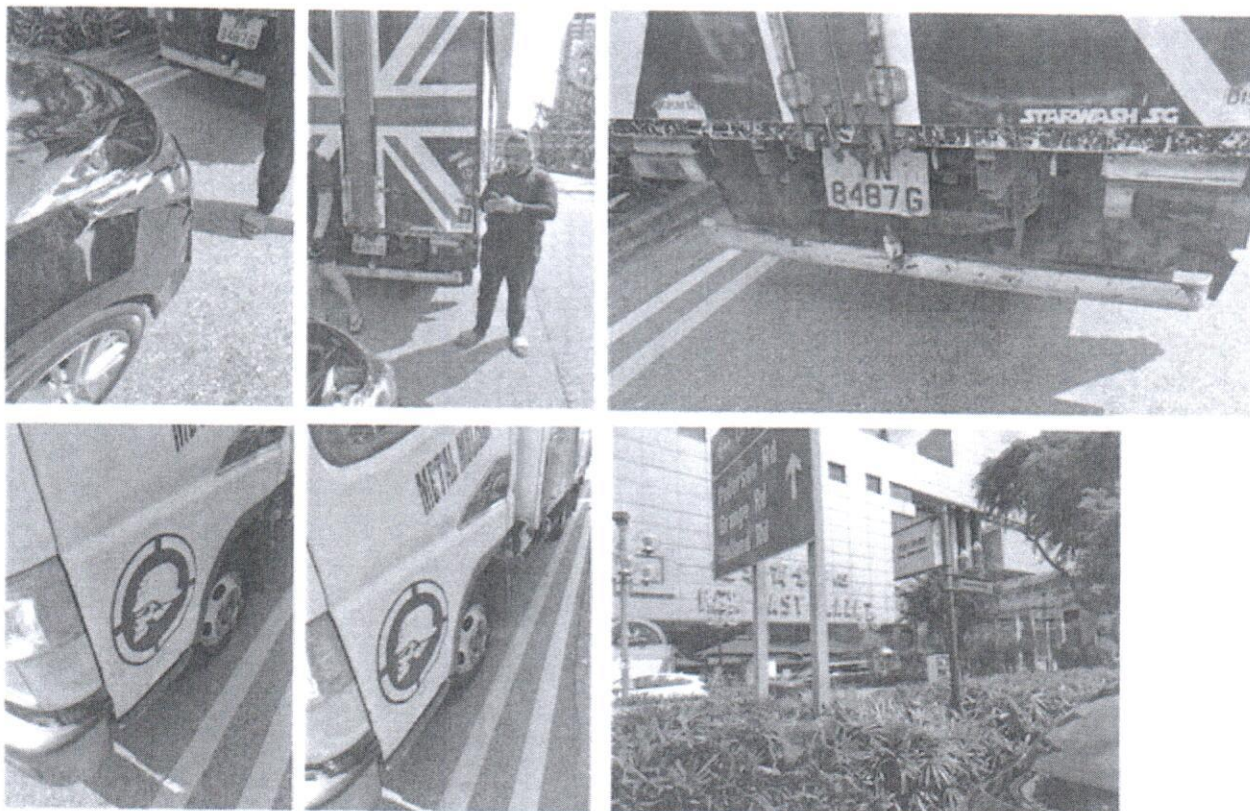

YN8487G and 54H3893K was at the exit of Far East Plaza Shopping Centre. YN8487G at the right outer lane in front of Scotts main road. Both cars were waiting for the main road to clear before turning out. My car was stationary as I cannot see the oncoming vehicle from the right as it was blocked by YN8487G.

Suddenly I noticed that YN8487G move ahead and start to turn right, I quickly honned at them because it was an acute turning and will hit my car. However, they didn't notice it and just make a turn and hit on the right side of my car and drag a little distance. Once they noticed the knock, the driver quickly reverse back the lorry as my front fender was stuck with their vehicle. After that they move forward again a park at the side of the main road. I follow suit and park behind them for a discussion. Driver claims that he did not notice my car because he was driving the lorry and sitting too high to notice I was beside him. we had exchanged our particulars and left the scene since there are no injuries sustain and also to avoid the jam as the traffic has start building up.

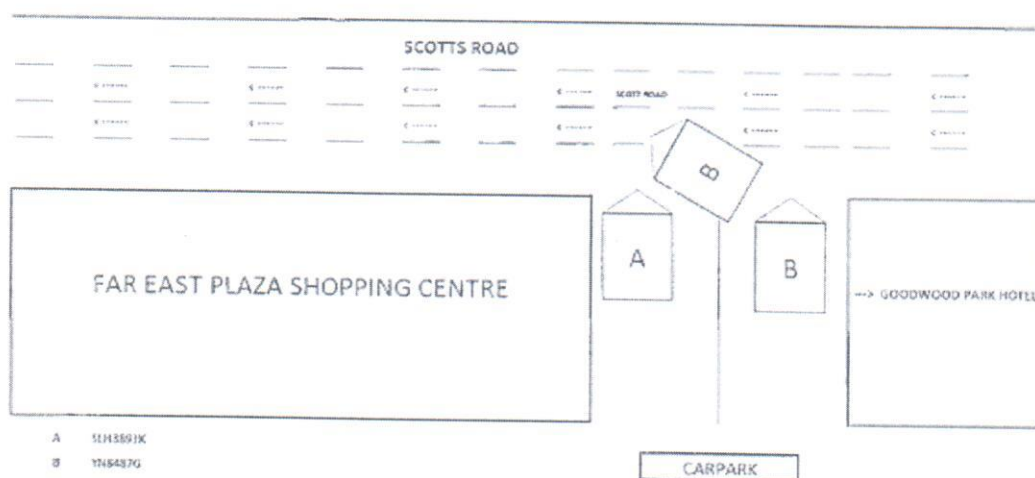
