Brief Details.

On the 04/11/2021 at about 1657hrs, I was riding my motorcycle (FBB2616B) along Stevens Road nearby to Singapore Chinese Girls School. It is a 4 lane road and I was on the 1st lane. I was heading towards Far East Plaza direction. I was about to start work. I saw that the traffic light ahead of me had turn red and I was gradually slowing down.

Suddenly, I felt an impact on my left side and I loss control of my bike and I fell down and rolled on the ground for certain distance. There was a fellow rider Mr Sham (HP: 90126828) who witnessed the accident. The witness told me that he saw this car driver (SHD2364X) behind me did a filter to the 3rd lane and suddenly filter into my lane thus causing the accident. After the accident, the other party who is a car driver (SHD2364X) came out and started pushing the blame onto me, claiming that he already signaled.

My motorcycle handle bar, fairing, headlights, forks, foot rest all became badly damaged due to the accident. I vaguely remember I saw that the car driver right mirror area sustained some scratches. The police came shortly after to manage the accident. The ambulance arrived shortly after and when I was in the ambulance, I saw that TP also arrived. I gave my DL to the TP officer.

I was conveyed to SGH and I received 7 days MC as a result of the traffic accident. I sustained abrasions on both arm, legs, ribcage and back. I also felt pain in my left shoulder area. I do not have any vehicle camera.
