



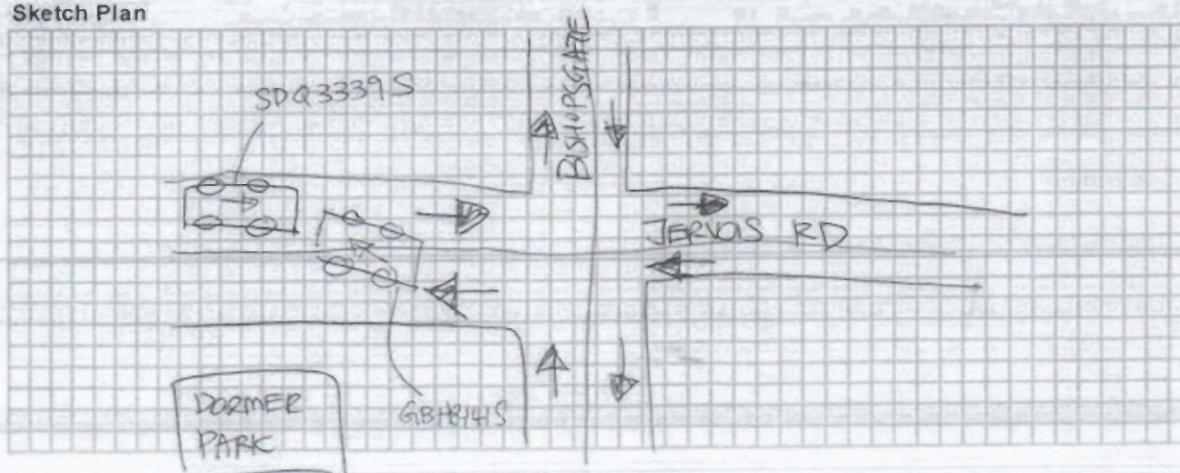

Sketch Plan






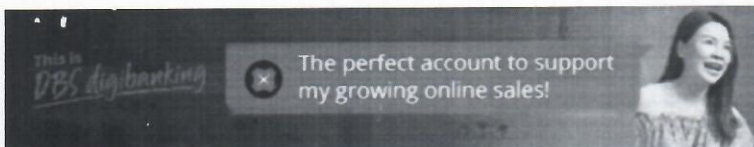


