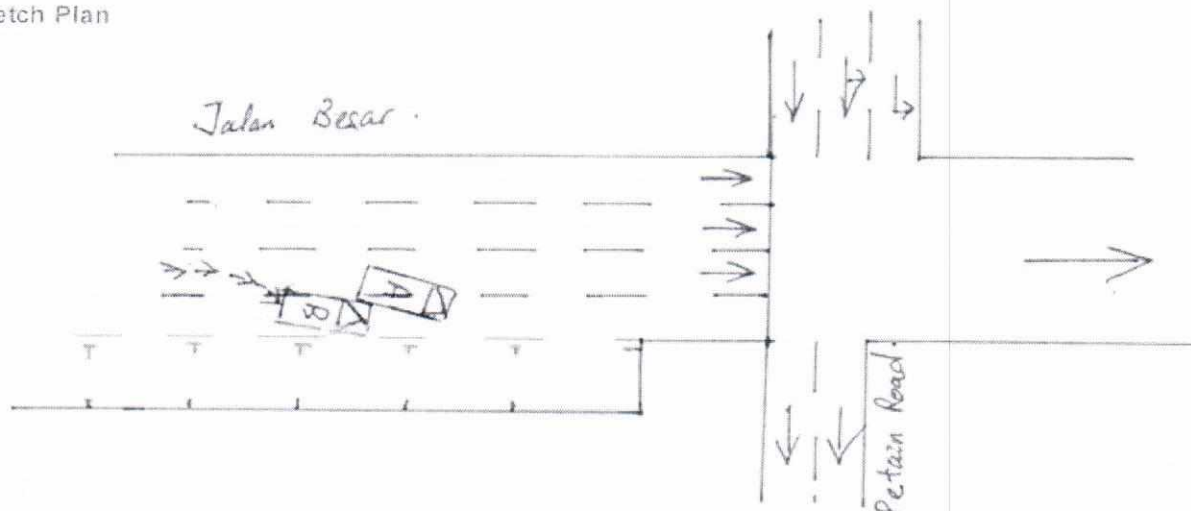

Describe Circumstances of the Accident

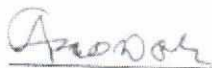
On 12/11/2021 at @ 1304 hrs, I was travelling in my vehicle (GBJ 607Z) along Jalan Besar before the junction of Petan Road on the 2nd lane from the right. I switched on my right signal as I wanted to change to the extreme right lane. I checked there were no oncoming vehicle and I changed slowly into the right lane. Suddenly, a taxi (SHD 2663H) travelling on the 2nd lane behind me speed up and could not stop in time, and swerved to the right. As a result, the taxi front left portion collided onto the right rear side of my vehicle.

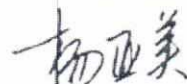
