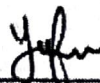

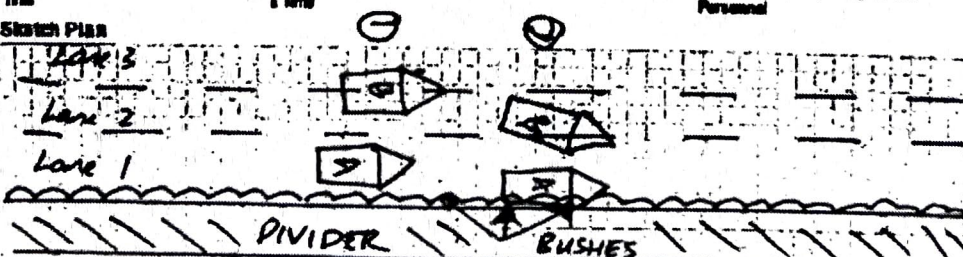

Brief Details.

ON 29/10/2021 at around 1037hrs. I was driving my vehicle, a dark blue Mazda 3 bearing the registration number of SMC8778S, along Kranji Expressway (KJE) and I was heading towards Pan-Island Expressway (PIE). At that point of time, I have one passenger on board as I am working as a private hired driver. While I was cruising at the right most lane, I noticed another vehicle, a Silver Mercedes Benz bearing the registration number of SIGM1500T, coming onto my lane from my left. As it was edging very close to my vehicle, I sounded my horn to alert the driver but he was cutting into my lane.

To prevent collision, I started to swerve to my right which caused me to graze against the bushes along the expressway divider. The other vehicle then sped up and move off without signaling to stop or assist. I wish to add that my vehicle sustained damages such as a damaged right side mirror and some scratches on the front right side of my vehicle.

I wish to add that no one was injured and this is the first time such incident happened to me. My passenger (Mr Liu, 9190 9028) was also fine after I dropped him off.
