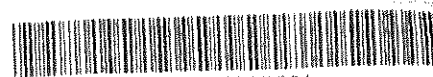

**Brief Details.**

On 04/09/2021 at around 0830hrs, while I was travelling on Lorong 2 Toa Payoh Slip Road towards PIE (TUAS) on my vehicle (SKF1551H) on the right lane.
