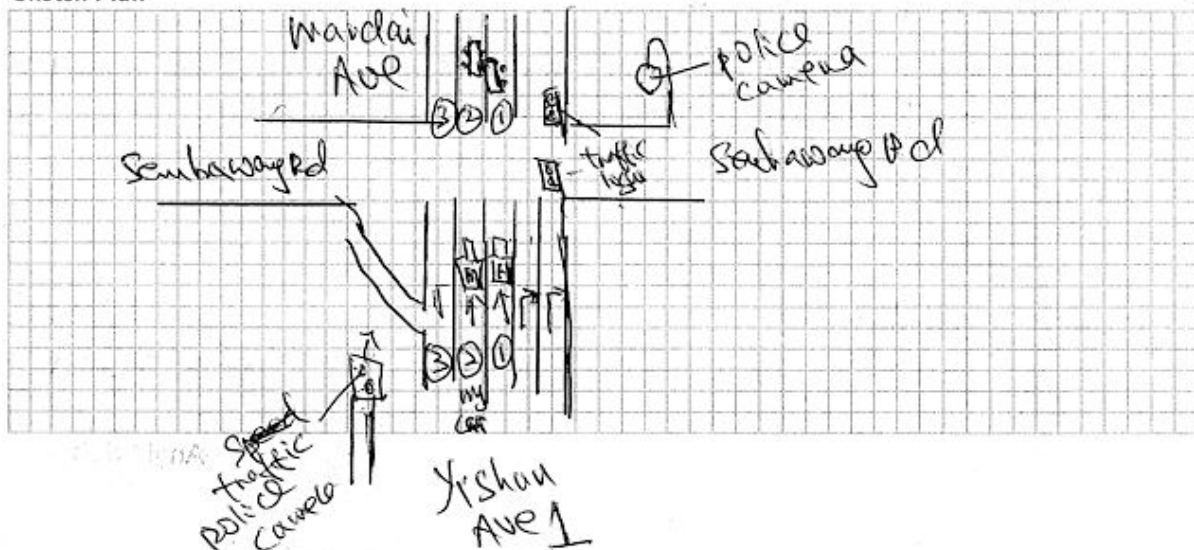

On 21/11/21 at around 9.25am, my car ~~(M)~~ ^(H) and his car ~~(H)~~ ^(M),
 my car SKZ 9706X and his car ~~(H)~~ ^(M), SMT-20856,
 both stopped at the sketched cross road junction.
 we were the 1st car at the traffic light junction.
 He was at the (1) lane & mine on the (2).
 we both moved forward when the light turned
 green.

After crossing the junction & moving towards the
 Mandai Ave, his car suddenly ~~cut~~ ^{cut} into my lane
 & ~~cut~~ ^{cut} hit the right side of my car despite me keep pressing
 on my horn to warn him. After moving ~~forward~~ ^{slightly} forward to free
 the collision, we both came out of the car. He denied
 cutting into my lane & accused me, instead, of cutting into
 his lane despite the fact that an Indian driver in an orange ~~(?)~~ ^{red}
 car came by & told him that it was his fault.
 He refused to give his IC & phone NO & he didn't want
 to wear mask throughout the whole incident despite reminder.

Brief Details.

On the above mentioned date and time, I was driving along Yishun Ave 1 towards Mandai Ave, at the cross junction between Mandai Ave and Sembawang Rd at the traffic light junction. I stopped my vehicle at the second lane. There was another vehicle bearing registration plate number SMF2085G stopped at first lane. When the traffic light junction turned green, I travelled straight and the other vehicle hit onto my rear right side while trying to turn into my lane. There were scratches at the right rear side while the other vehicle have scratches at the front left side. I asked him why you come into my lane, but he replied that he did not come into my lane and accused me of driving into his lane. He refused to accept that he drove into my lane. He refused to provide any particulars and drove off. There were a passerby who saw and said that it was his fault and left (No particulars from the witness).

I wished to state that I do not have any car camera installed in my vehicle. The driver who exited his vehicle was observed not to be wearing any masks throughout the whole incident.
