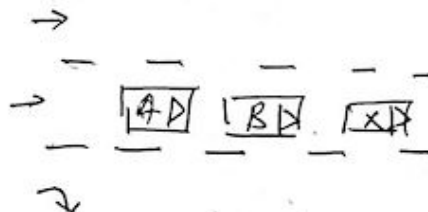

Sketch Plan

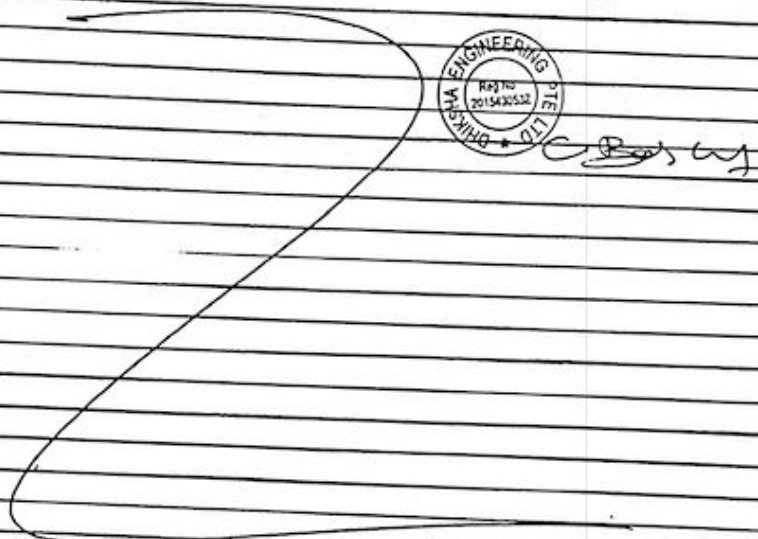
