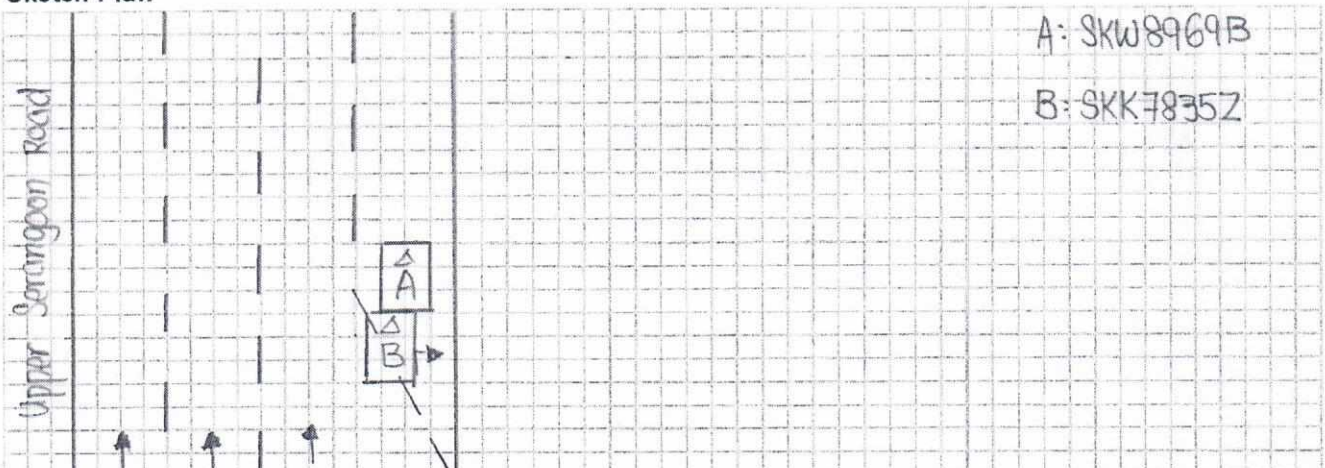

Sketch Plan






