CIRCUMSTANCES OF ACCIDENT

On 21 Nov 2021, at about 9.39am, I was driving vehicle A (SGE555G) along Dunearn Road on the rightmost lane (Lane 1) of a 3-lane carriageway. I indicated my right turn signal to turn right into Farrer Road at the junction of Dunearn Road and Farrer Road. Based on the lane markings, I am supposed to turn right into lane 3 of Farrer Road.

As I approached and turned into lane 3 of Farrer Road, a white car, vehicle B (SMZ3770A), which was originally on lane 2 of Dunearn Road and turning into lane 4 of Farrer Road, suddenly without any turn signal indication, consideration and due care, made an unsafe lane change, cut recklessly and dangerously into lane 3 of Farrer Road, which was the lane I was already travelling straight in and ahead of the said vehicle B. Based on the lane markings, vehicle B was supposed to only turn right into lane 4 of Farrer Road and remain in its lane without encroaching into the adjacent lane.

I immediately applied the emergency brake of my vehicle, but vehicle B continued to recklessly move from lane 4 into the path that my vehicle was travelling straight in on lane 3. As a result, vehicle B collided into the left side my vehicle at a diagonal angle from lane 4 to lane 3.

As a result of the aforementioned collision, my vehicle suffered damages to its front bumper, left front fender, left front rim, left door, left side skirt, left wing mirror, etc...(other damages to be indicated after assessment by the workshop).

The particulars of the driver of vehicle B are as follow - Sia Kim Bock, D.O.B 19 Sep1959, and NRIC no. S1396597H. He refused to divulge his insurance information. His contact no is 8287 6946 and address is "23 Chai Chee Road, #09-464, Singapore 461023". I would like to add that when the driver of vehicle B alighted from his vehicle, he remarked without hesitation that he did not see my vehicle and apologized for the collision.

SKETCH PLAN





Based on the lane markings, vehicle B was supposed to only turn right into lane 4 of Farrer Road and remain in its lane without encroaching into the adjacent lane. LANE 4 OF FARRER ROAD, SUDDENLY WITHOUT ANY TURN SIGNAL INDICATION, CONSIDERATION AND DUE CARE, MADE AN UNSAFE LANE CHANGE, CUT RECKLESSLY AND DANGEROUSLY INTO LANE 3 OF FARRER ROAD, WHICH WAS THE LANE I WAS ALREADY TRAVELLING STRAIGHT IN AND AHEAD OF THE SAID VEHICLE B. BASED ON THE LANE MARKINGS, VEHICLE B WAS SUPPOSED TO ONLY TURN RIGHT INTO LANE 4 OF FARRER ROAD AND REMAIN IN ITS LANE WITHOUT ENCROACHING INTO THE ADJACENT LANE.

I IMMEDIATELY APPLIED THE EMERGENCY BRAKE OF MY VEHICLE, BUT VEHICLE B CONTINUED TO RECKLESSLY MOVE FROM LANE 4 INTO THE PATH THAT MY VEHICLE WAS TRAVELLING STRAIGHT IN ON LANE 3. AS A RESULT, VEHICLE B COLLIDED INTO THE LEFT SIDE MY VEHICLE AT A DIAGONAL ANGLE FROM LANE 4 TO LANE 3.

AS A RESULT OF THE AFOREMENTIONED COLLISION, MY VEHICLE SUFFERED DAMAGES TO ITS FRONT BUMPER, LEFT FRONT FENDER, LEFT FRONT RIM, LEFT DOOR, LEFT SIDE SKIRT, LEFT WING MIRROR, ETC... (OTHER DAMAGES TO BE INDICATED AFTER ASSESSMENT BY THE WORKSHOP). I WAS ALSO INJURED IN MY RIGHT SHOULDER AND WAS GIVEN 3 DAYS MC BY MY DOCTOR ON 22 NOV 2021 (INCLUSIVE).
