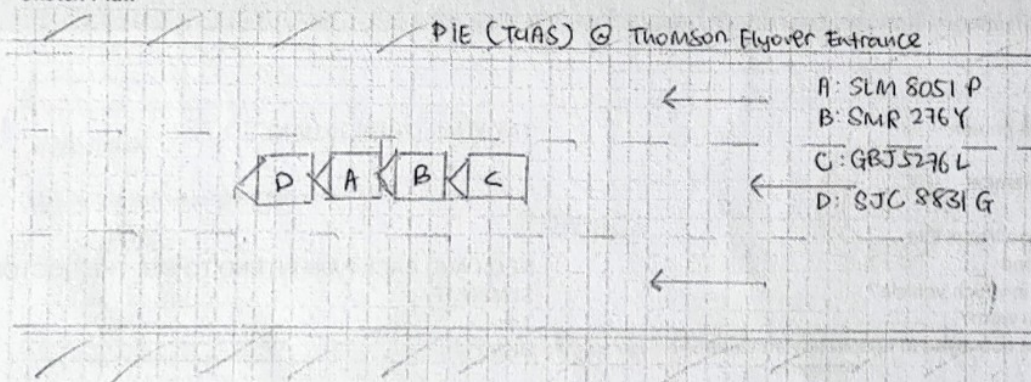

I was driving vehicle A along AE (Tras) at Entrance to Thomson Flyer. Vehicle D in front of me stopped. I slowed down and stopped too. Vehicle B behind of my vehicle stopped too. After a few seconds, I heard a ~~loud~~ bang from behind. Vehicle C collided into vehicle B. The heavy impact pushed vehicle B to hit the rear of my vehicle. Subsequently, the impact caused my vehicle to surge forward and hit into the rear of vehicle D. The traffic condition at the point of accident was very slow & heavy.
