Brief Details.

On the 23.11.2021 at about 11.30am while I was driving my vehicle bearing the registration GBH9199K at the third lane along Pan-Island Expressway towards Tuas, a lorry bearing the registration number YP5014Y had knocked against the rear of my vehicle. Due to that, my vehicle had knocked onto the rear of a vehicle bearing the registration number SH9249Z.

During the accident, it was raining and the road was wet. I was driving my vehicle and vehicle SH9249Z which was travelling in front on the same lane had slowed down. As such, I slow down my vehicle when driving at the rear of the said vehicle. However the vehicle YP5014Y did not and had hit the rear of my vehicle.

The impact of the accident was bad that caused both the rear and front of my vehicle were dents and scratches. There were slight damages on my vehicle. Due to the impact of the accident, I sustained back pain, nausea and I started vomiting. Subsequently, I went to seek medical treatment at Healthway Medical which was located at 101 Towner and was given 3 days MC from 23.11.2021 to 25.11.2021. I already informed my insurance company and supervisor and was advice to seek medical treatment and lodge the accident report.
