On 17th OCt 2021, my car, SDS 905S, was parked at blk 542A Serangoon North Ave 4, multi-storey carpark around 2.30pm. I went grocery shopping at the nearby Prime supermarket. On my the return the driver of a red Hyundai I30 SJS 8783 Y which was parked beside my car was present. He approached me and claimed that I had hit his car while parking. His car was stationary in the next lot when I parked. (I did not have my phone / camera with me & could not take pictures. I may have recorded his car number wrongly. It could be SJS 8786).

I told him I did not thnk that I had hit anything while parking but was prepared to listen to his allegation. He showed me a few scatches on the driver's side of the car, near the front. They were yellow scratches on his red paintwork. There was no dent. I took a wet cloth from my car to wipe the scratches, the marks that I wiped came off. He stopped me from wiping some more. What was left visible was 2 thin shalllow lines around 2cm long. I could not verify if by wiping the 2 lines could go off as he pevented me from doing. I told him if the lines cannot be wiped out, or I could try polishing the shallow lines. It could settle the matter as I was not aware I had hit his car. He was not wearing a mask and shouted disagreement at me.

He told me he was a GRAB driver and that he had hired his car, so he had to report to the car hire company of the accident to let them decide. He also referred to the scratches at the back of my car and claimed that it was evidence that I had hit him. I informed him those were old scratches. He did not want to exchange phone numbers with me.

As he was not prepared to settle the matter privately, I am left with no alternative but to make this alleged minor accident report. I must stress that there were only 2 thin lines, no dents, no other damage and that I was not aware that I had hit his car. (My car was parked next to his and I did not attempt to drive it away)
