Brief Details.

On the above mentioned date, time and location, I was riding my motorcycle bearing (JSR1578). I was riding on the third lane at a normal speed towards the traffic junction. All vehicles were positioned stationary as it was a red light. When a car, bearing (SJL8891E) from the second lane suddenly did a lane change. I could not react in time and we collided. Another rider who was around, saw what happened and assisted me to move to the side. Later ambulance arrived at the location and I was conveyed by the ambulance to Ng Teng Fong General Hospital.

I suffered an AC joint dislocation on my right arm and knee abrasion on my left knee. I was discharged on the same day at about 2200hrs and was given 7 days MC.

On 13/10/2021 at about 0800hrs, Traffic Police called me and informed me to lodge a road traffic accident report at the nearest police center.
