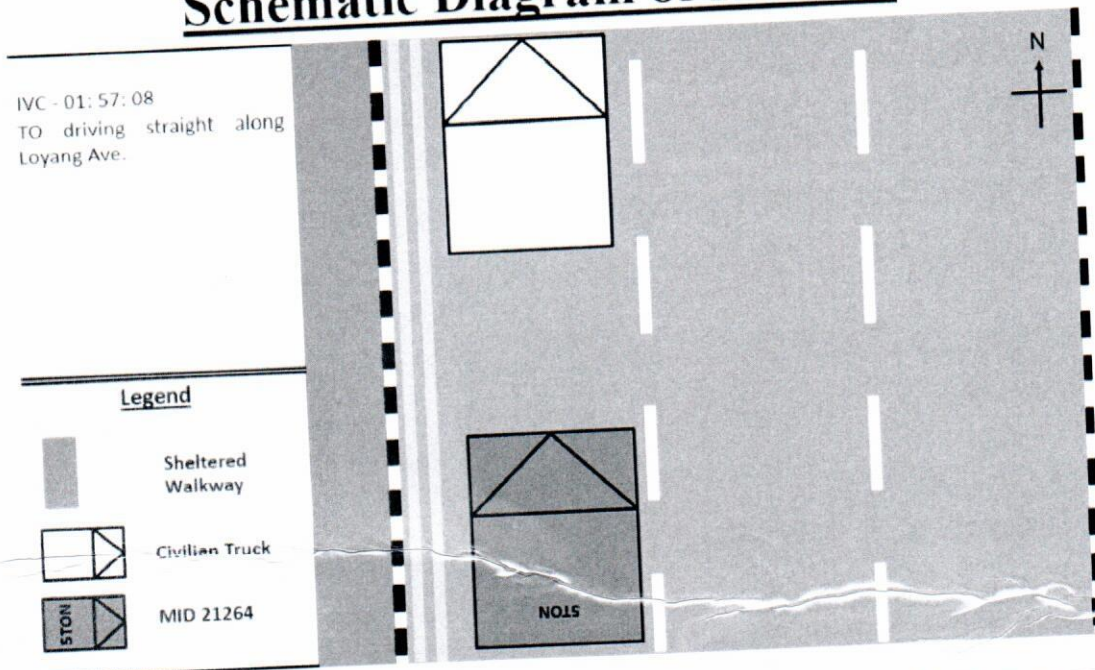

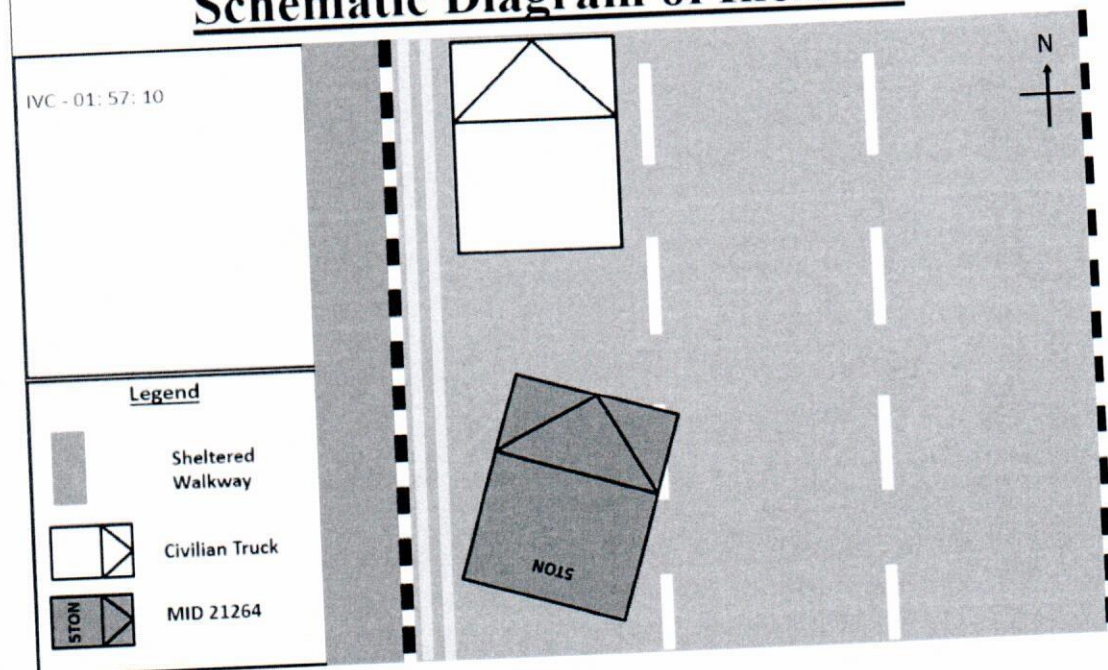

## Schematic Diagram of Incident

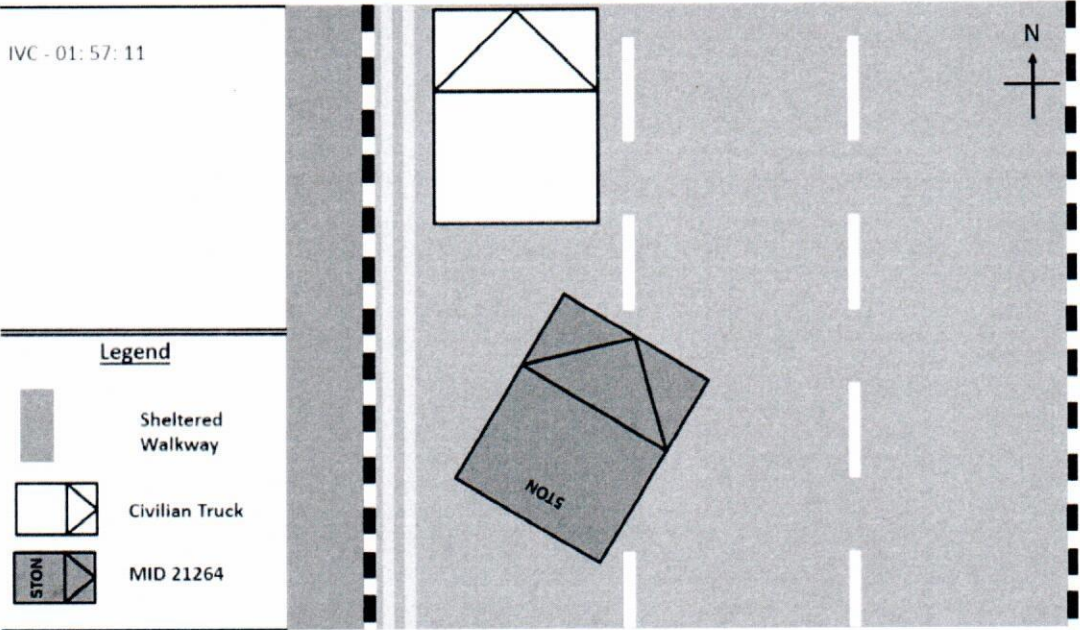

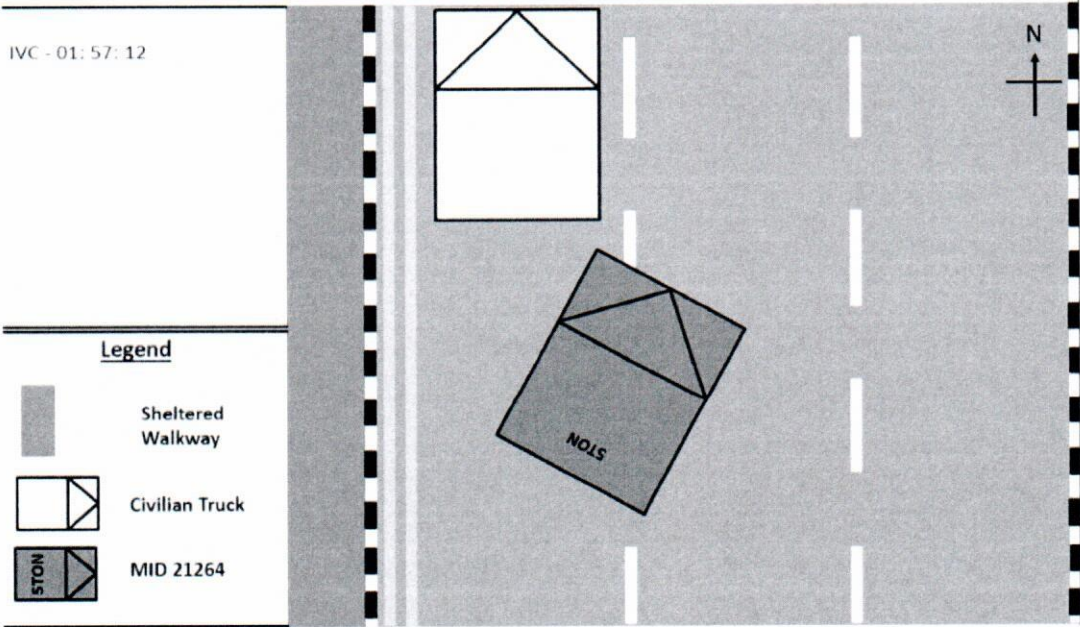

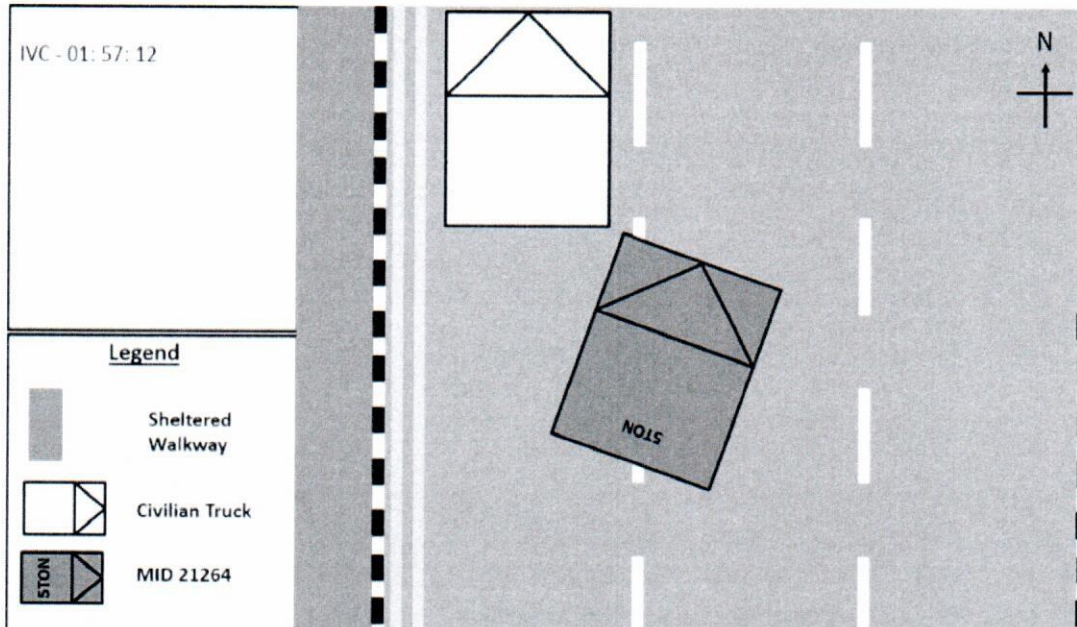

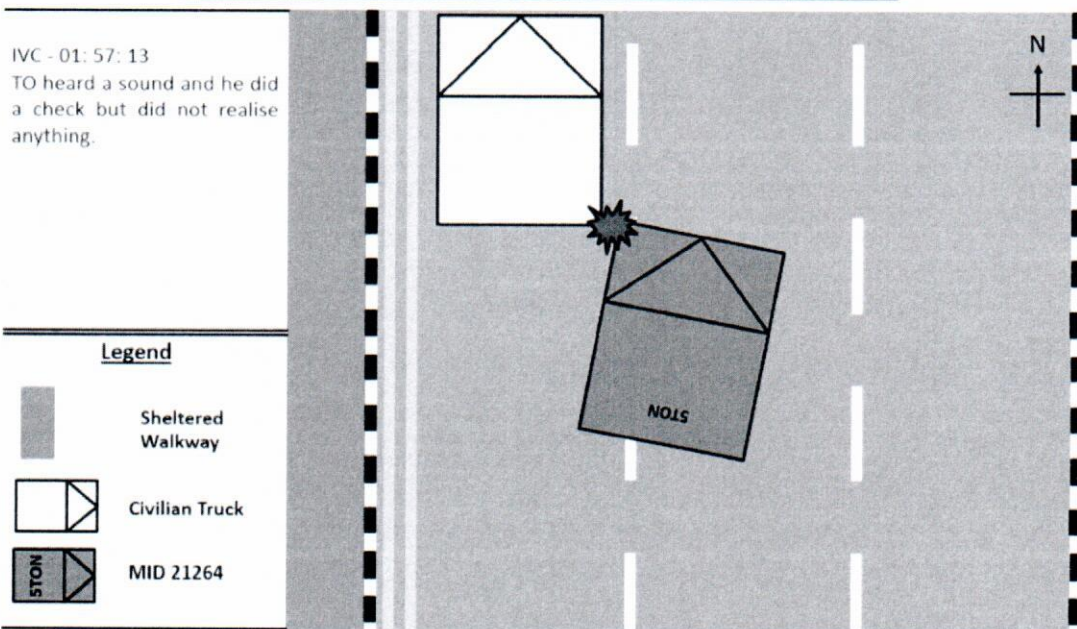

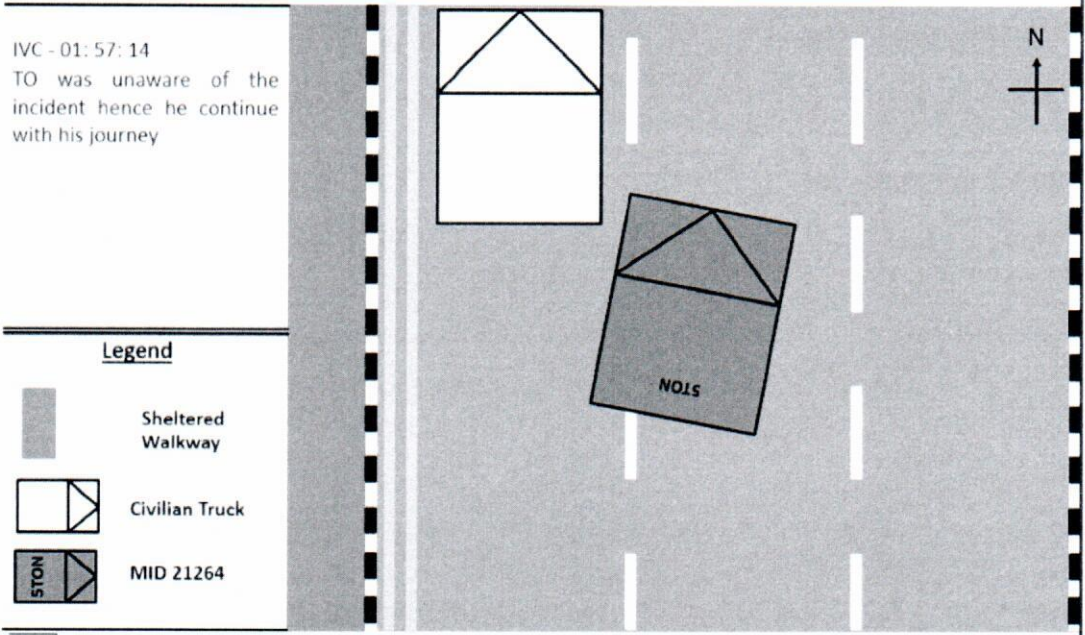

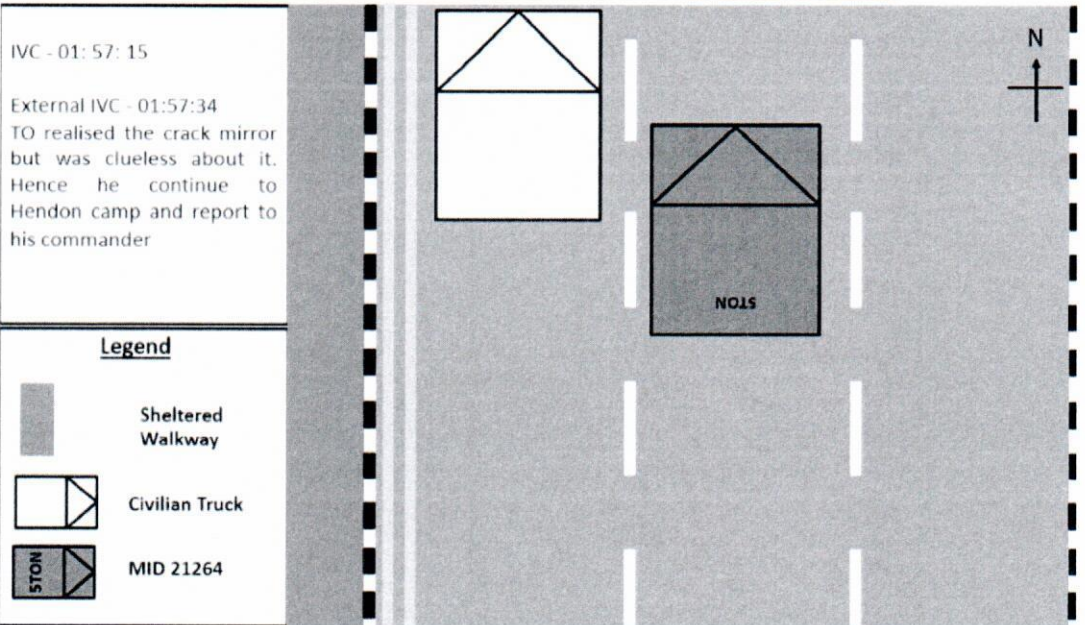

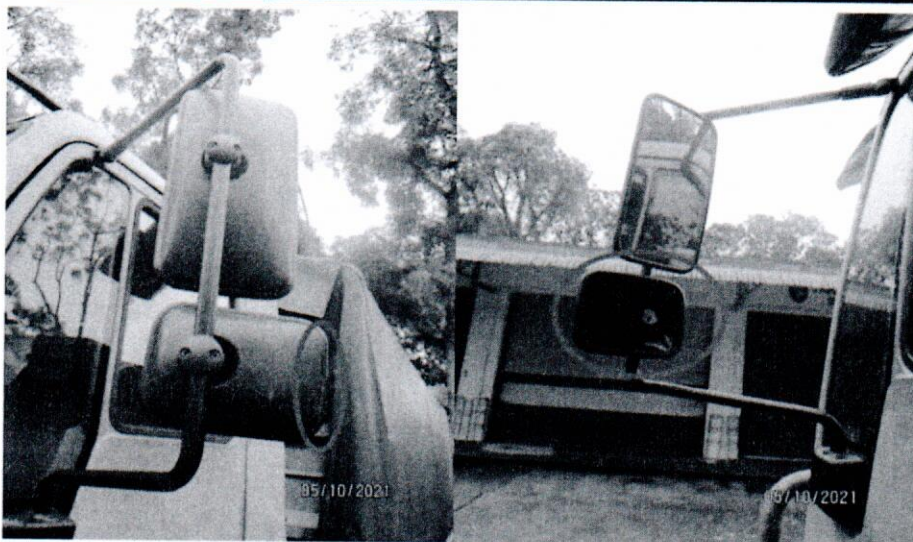

CONTINUATION OF REPORT

**Brief Details.**

On 04/10/2021 at around 1400hrs, I was driving the SAF 5 ton military vehicle along Loyang Avenue towards Changi. The weather was clear and the road surface was dry. While I was driving along the road, I was on the extreme left lane. However the lane was a left turn only lane. As such I needed to change to the lane on the right to drive straight towards Changi. While I was changing lane, there was a huge truck with a big metal container on the back in front of my vehicle.

When I changed lane, I misjudged the maneuvering of my vehicle and my left side of vehicle hit slightly onto the rear of the truck. It caused the lower left side mirror to be damaged as a result of it. I only realized it slightly later when I was driving. However I do not recall the truck vehicle plate number and both vehicles did not stop. I am lodging the report as I am unsure if the truck was aware of the minor collision from my SAF 5 ton onto the rear of the vehicle.
