Please review the footage video. From the video footage, it is evidence that your principle's insured allegation was completely inconsistent as shown in the footage. Please also refer to both statements in your possession and we believe, you would agree with the following facts.

1. Although the traffic light was faulty, based on the bola the vehicle going straight has the precedence.
2. The actual collision was occurred inside the yellow box and not after or further from the yellow box.
3. SLU 8204 Z was all the way before and after traffic light, cruising on his own lane. He did not switch nor cut lane.
4. SLF 9457 's view was being blocked by the vehicles stopped on the right side waiting to turn right at the traffic light junction.

Your offer at 50% is strongly rejected by our client. Our client demand for 100% settlement. We urge you to seek mandate from your principle to reassess the true position of the collision.
