



Describe Circumstances of the Accident

On 29 Nov 21 around 1:00 Pm Driver Samiyappa used to drive the 14 Ft Lorry vehicle no YP 4770D and he had parked the lorry at Burmah road Placed adjacent to Serangoon Road (Opp to 300 Condvium Square)

After 30 mins around 1:30 Pm time he intend to drive the lorry to the site, during the course he was driving behind as there was a car parked in his front and the rear side also a car had parked with the vehicle no GBC 7716H

While he was reversing his Lorry to position the vehicle to move, accidentally the Rear side (centre) of the lorry hit against the parked vehicle. Result the number plate was damaged and around the side of the car sustained with marks. The driver was in the car during the accident and no body injury has been taken place during this incident.
