Re: Medical Report of Mr Por Jinfeng (S8123187G)

The above patient was seen at our clinic on 25th February 2021 for complaints of back pain after being involved in a road traffic accident which happened on 24th February 2021. He was the driver of a vehicle involved in rear end collision from another vehicle. During the accident, he was wearing safety belt. There was no headache, giddiness or blurring of vision noted. There was no complaint of any focal weakness or numbness. No breathing difficulties were noted either. He has a notable history of prolapsed intervertebral disc.

On examination, his vitals were stable. His blood pressure was normal at 118/74 mmHg. The range of motion of his neck was full with no localised tenderness. The range of motion of his back was full with tenderness over his lumbar region. No focal neurological deficits were noted. No swelling, open wound or bruising was noted. His vision and hearing was unremarkable. His gait was normal. The rest of his systemic examination were otherwise unremarkable. He declined analgesia for pain relief. He was given medical leave of 2 days duration from 25th February 2021 to 26th February 2021.

He revisited us on 19th March 2021 for back pain with radiation to his left leg of 1 week duration. Physical examination revealed full range of motion of his back with tenderness over his lumbar region and limited straight leg raise bilaterally. His gait was noted to be antalgic.

Clinical impressions were that of:

Back strain injury with radiculopathy


He was given oral analgesia for pain relief. No X-ray or medical imaging was done during both his visit. He was given medical leave of 2 days duration from 19th March 2021 to 20th March 2021. He was advised to seek review at the

hospital with an Orthopaedics specialist if persistent symptoms were noted. There was no further follow up subsequent to 19th March 2021.



Be advised that **POR JINFENG (NRIC#: S8123187G)** presented at our clinic for low back pain on 27th March 2021 following an automobile accident that occurred on 24th February 2021. His first appointment at the clinic was on 20th February 2021 where he complained of neck and low back discomfort. He states of localized pain in the neck region causing tightness in the trapezius region. The low back discomfort was localized and comes and goes with prolonged postures. He was treated with spinal manipulative therapy along with adjunct physical modalities.

History:

He states of pain in the low back region that was aggravated after the accident. He reported going to the General Practitioner. No imaging was performed. He was then discharged from the General Practitioner with pain medications. He complains of numbness and pain down the left lower extremity affecting his left ankle joint. Walking is affected and limited by pain. The pain is constant. Visual analog scale – 8/10. Nothing seems to make it better. No other significant illness/diseases noted. Patient denies any long-term medications or surgeries.

Orthopedic tests:

Patient's range of motion of the low back is limited by pain during flexion. Straight leg raiser test is positive with radiating pain down the left posterior thigh, calf and ankle region.

Diagnosis:

Acute lumbar spine sprain/strain with radiculopathy.

Treatment plan:

Patient is undergoing spinal manipulative therapy with adjunct physical modalities for his condition. Patient is scheduled to receive treatment twice a week. In his initial visits from 27th February 2021 to 9th March 2021, the physical modalities used were Therapeutic Ultrasound and ESWT (Extracorporeal Shockwave Therapy). Unfortunately, the condition was not improving. Of which, he was recommended for an MRI imaging. The patient preferred to source for his own imaging centre. A memo was written for him to do so at an imaging centre of his choosing. His treatment plan was then modified. Instead of the Therapeutic Ultrasound and ESWT, Spinal

Decompression was performed along with spinal manipulative therapy. After the change, the patient is responding better, and the radiating pain and numbness has reduced. His condition will be re-evaluated for further intervention and/or referral, if necessary.

Prognosis:

Good. Patient is expected to recover well. However, proper rehabilitation is recommended to minimize the possibility of exacerbation of the condition.
