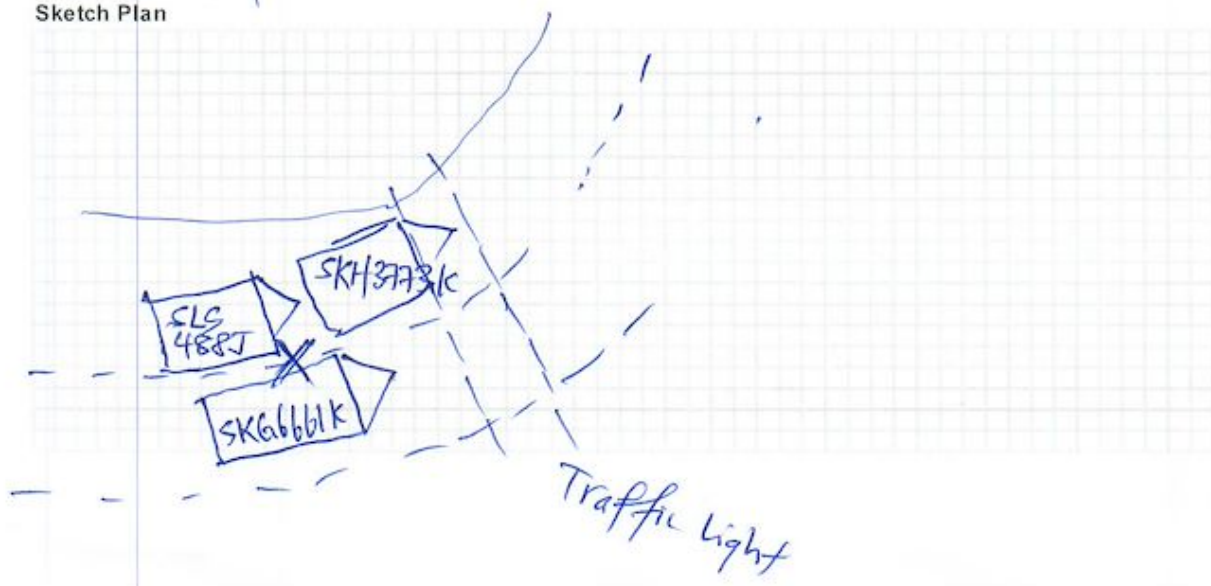

Describe Circumstances of the Accident

At about 957AM, I was driving along Tiong Bahru Road at about pedestrian traffic light near D Hotel, SKH 3773K, came to a stop because a wheel-chaired man was half on the road and half on the pavement. I was driving behind SJS 488J, who filtered into the same lane as SKH 3773K. As both vehicles are stopped, I did not stop and continued as the road next lane where I am in was cleared. After I drive passed SJS 488J, my car was hit from the left side from front passenger door onwards.

I immediately stopped and that was when SKH 3773K filter a bit into my lane and continued his journey. My car did not hit or damage SKH 3773K. Both drivers (me and SJS 488J) came down the car and check for details, took picture and exchange contact information.

I hit my right wrist and so was my son and daughter, while my wife feel giddy, because of the impact. I told my wife to bring my girl home while my son to go for his tuition.

We then move the vehicles to a safe location and further check the vehicles. Damage to SJS 488J was his right bumper and rims, while my vehicle was hit on both lower doors (guards all dropped off), rear wheel misaligned and later I realised the steering was also not aligned. My rear left door cannot be opened fully.

Upon calling CRC, I am here to lodge the report and to claim third party ~~as~~ as the driver of SJS 488J filter out without checking blind spot.
