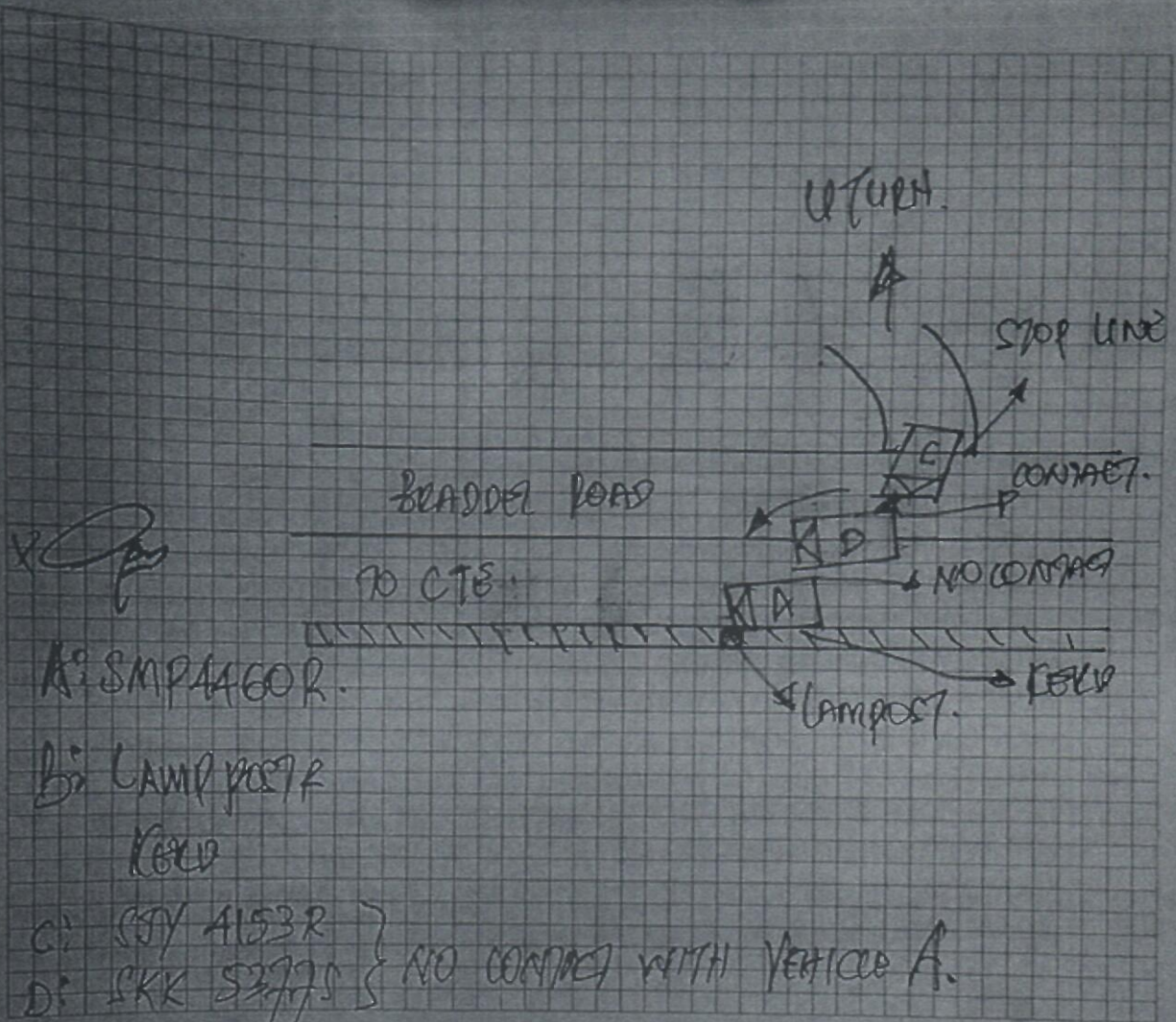



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON THE DATE AND TIME MENTIONED I WAS DRIVING ALONG THE SAID MENTIONED ROAD ON THE LEFT MOST LANE. AS I WAS DRIVING, SUDDENLY, SKK5377S, WHICH WAS HIT ON ITS RIGHT BY VEHICLE SJY4153R AND THE IMPACT PUSHED VEHICLE, SKK5377S, DIRECTLY INTO MY LANE AND SEEING, I JAMMED MY BRAKES AND MADE A SHARP LEFT TURN TO AVOID HITTING THE SAID VEHICLE SKK5377S. IN THE MIDST OF DOING THAT, MY VEHICLE MOUNTED THE KERB AND THE LEFT SIDE OF MY VEHICLE HIT THE LAMPPOST. THE CAUSE OF VEHICLE SKK5377S PROTRUDING INTO MY LANE BECAUSE IT WAS HIT BY SJY4153R, WHO FAILED TO STOP AT THE STOP LINE, WHEN MAKING A UTURN. NO BODY WAS INJURED.
