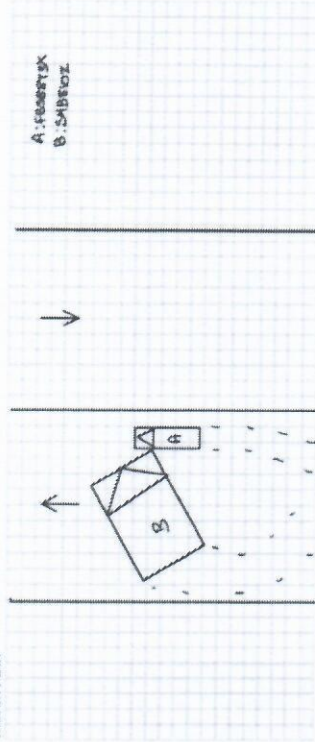

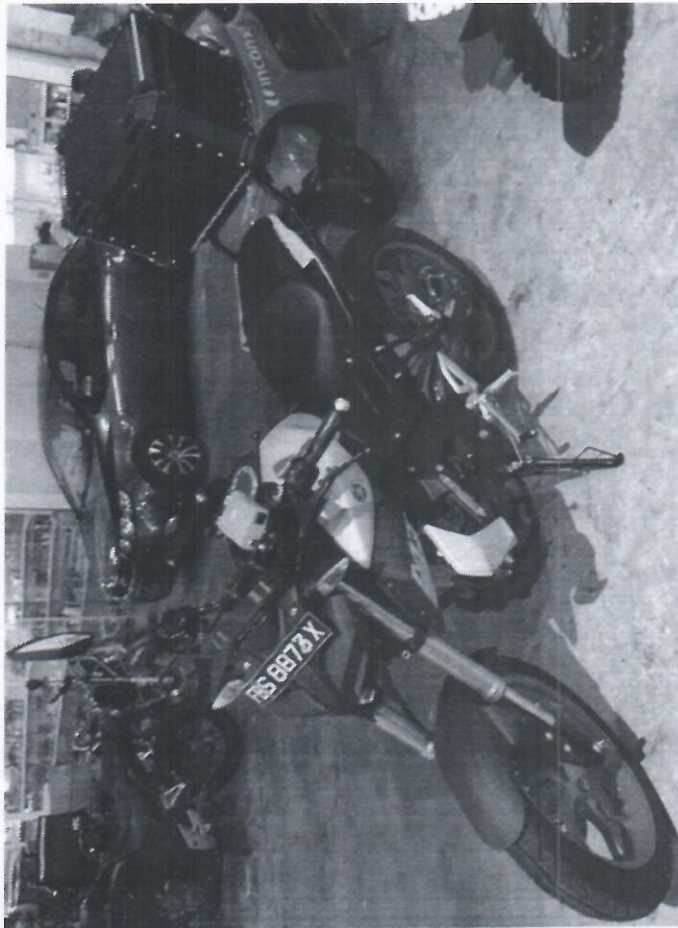

CONTINUATION OF REPORT

Brief Details.

On 17/11/2021 at about 01:50pm, I was riding my bike (FBS8873X) along Bedok North Street 2 on my way to work. I noticed one maroon taxi (SHB810Z) in front of me. The said taxi then turned on his hazard light, slowed down and swerved to the left. Thinking the taxi wanted to park at the side of the road, I decided to over-take him on the right. As I was over-taking the taxi, the said taxi suddenly turned right to make a U-turn. I was not able to stop on time thus collided onto the taxi. I fell and had injuries on my back, shoulder, calf and abrasion on my left hand. The taxi driver quickly stopped and came to assist me who then called for the ambulance. When the ambulance came I was feeling better and did not want to be convey to hospital. TP also arrived at the location and interviewed us. After taking photos and exchanging our particulars we left. Later in the day the pain was getting worse thus I went to Central 24-Hr clinic (Bedok) and was given 3 days of MC.

I would like to state that I was traveling at a safe distance and at road speed limit. Upon seeing the taxi slow down with hazard light and swerving to the left I decided to over-take him on the right. The road is a single lane. Further more the taxi tried to make a U-turn at the said location which cause the accident. I do not have camera in my bike however I believe the taxi might have one installed.
