Brief Details.

On 1/6/2021 at about 10.30am, I was riding along Keppel Road towards Tanjong Pagar direction (MCE (ECP/KPE) via Keppel Road). I could not remember exactly where and which lane did the accident occurred, however I recall that after the right bend, I was coming from the right side of the road, whereas on the left side of the road were vehicles from AYE and these 2 roads merged. I think I was at the center of the road then, and while I was riding I noticed that was a van bearing license plate GP6563K that was driving very near me on my left. Thereafter, I think I passed out and a passerby, whom I believe is the witness namely Azhari bin Musa, HP: 87517172 called me up when I was by the grass. He then identified himself and I took out my phone and asked him for his phone number. The next thing I knew, I was conveyed by ambulance to SGH. Doctor made an assessment and found out that my right collarbone and right thighbone were fractured. I underwent surgery and had metal plates on both my right collarbone and right thighbone. I then stayed in the hospital until 19/6/2021 and was given MC for 80 days from 1/6/2021 to 19/8/2021.

I do not know the exact damages that were done to my motorcycle and the other party's van. I do not have the details of the van driver. I do not have a camera installed on my motorcycle, however I am not sure whether if the van has any in-vehicle camera.

I wish to state that I received the letter from TP and was advised to lodge a police report.

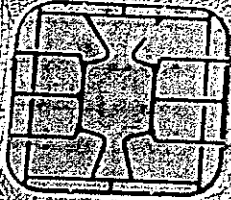
