SKETCH PLAN

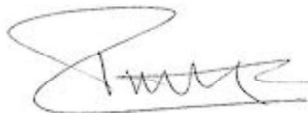

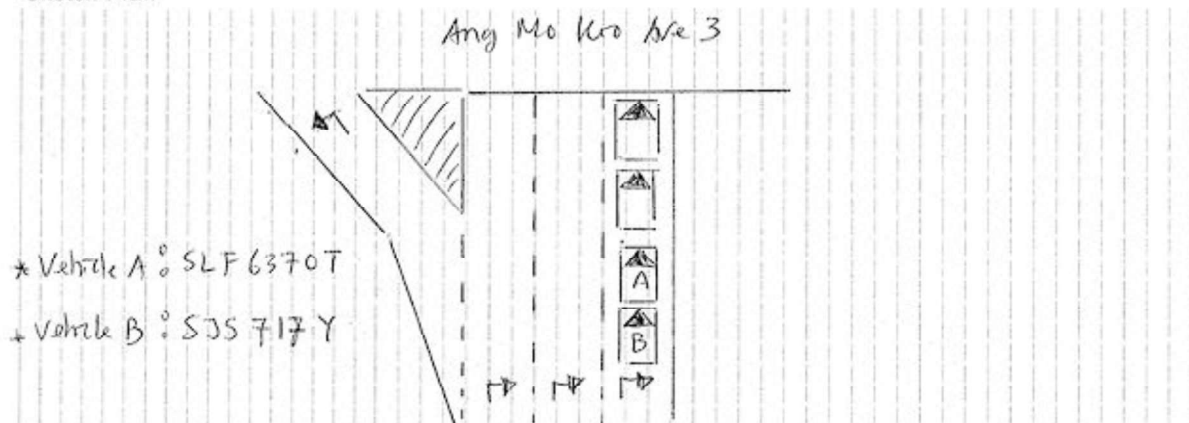

Sketch Plan

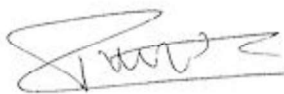


Describe Circumstances of the Accident

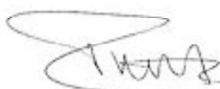
On the stated date and time, I was travelling at the stated venue.
